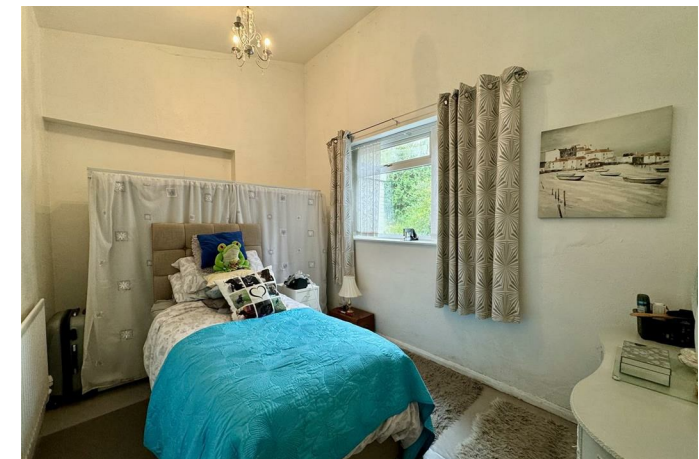

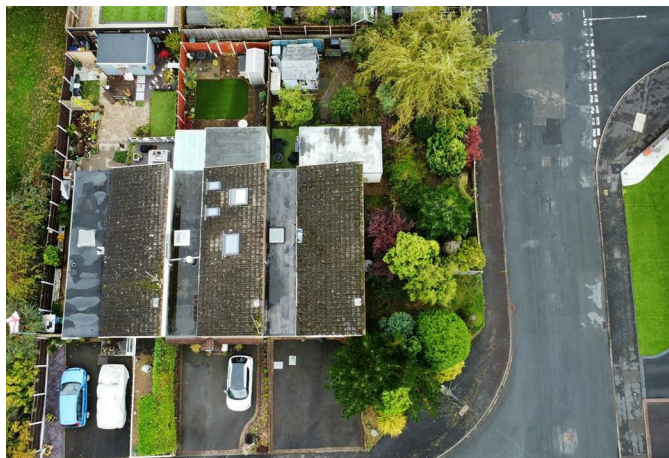

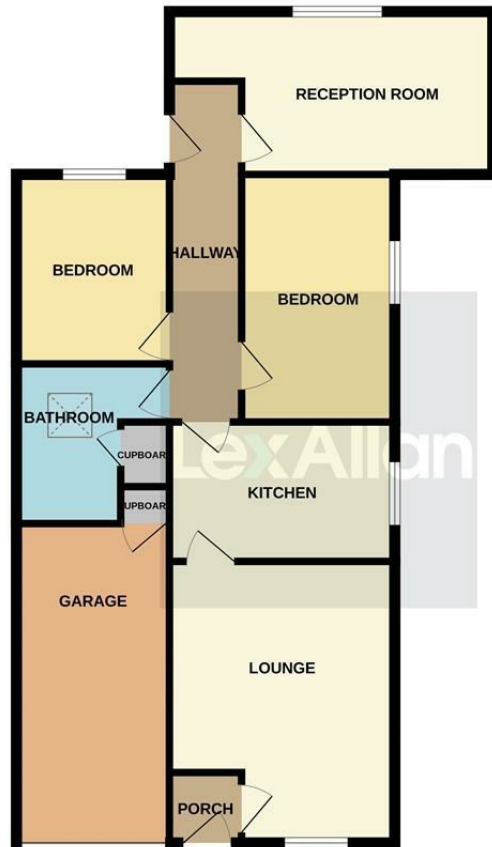
Tenure (Freehold).
