#### Approach

Driveway to front and lawn area to side.

#### Entrance Hall

Door to front, central heating radiator, cupboard and stairs off.

#### Lounge

10'2" x 17'1" (3.1 x 5.2)

Double glazed window to rear and doors.

#### Kitchen/Diner

8'2" min 11'2" max x 12'6" (2.5 min 3.4 max x 3.8)

Double glazed window to front, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, integrated oven, dishwasher, tiled flooring and splash backs, space and plumbing for washing machine and central heating radiator.

#### Landing

Central heating radiator, access to loft space, doors and cupboards off.

#### Bedroom One

8'10" x 11'6" (2.7 x 3.5)

Double glazed window to rear and central heating radiator.

#### Bedroom Two

7'10" x 8'10" (2.4 x 2.7)

Double glazed window to front and central heating radiator.

#### Bedroom Three

8'6" x 6'7" (2.6 x 2.0)

Double glazed window to rear and central heating radiator.

#### Bathroom

Double glazed window to front, WC, wash hand basin with mixer tap and storage below, bath with mixer tap and shower over, tiled splash backs and heated towel rail.

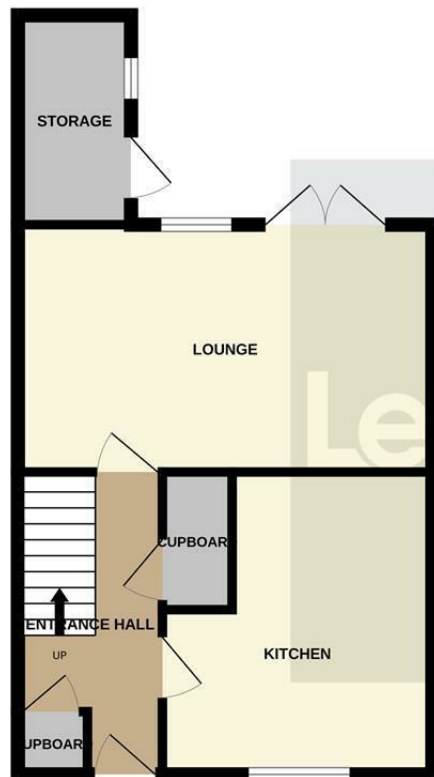
### Tenure (Freehold).

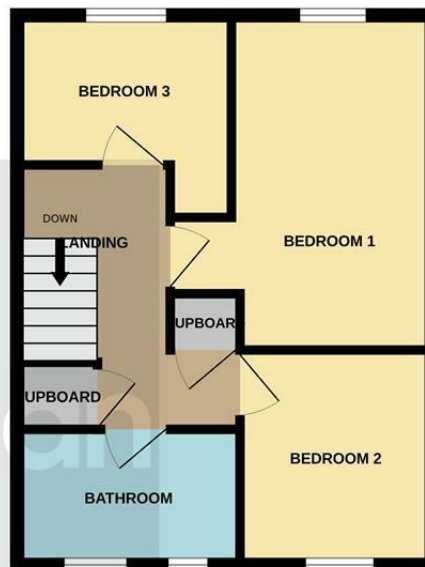
### Council Tax Band B



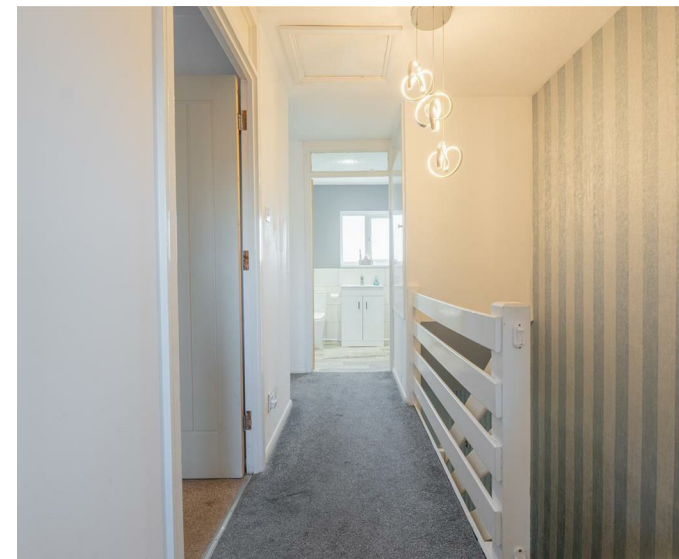
GROUND FLOOR
