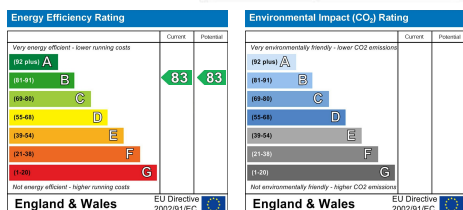
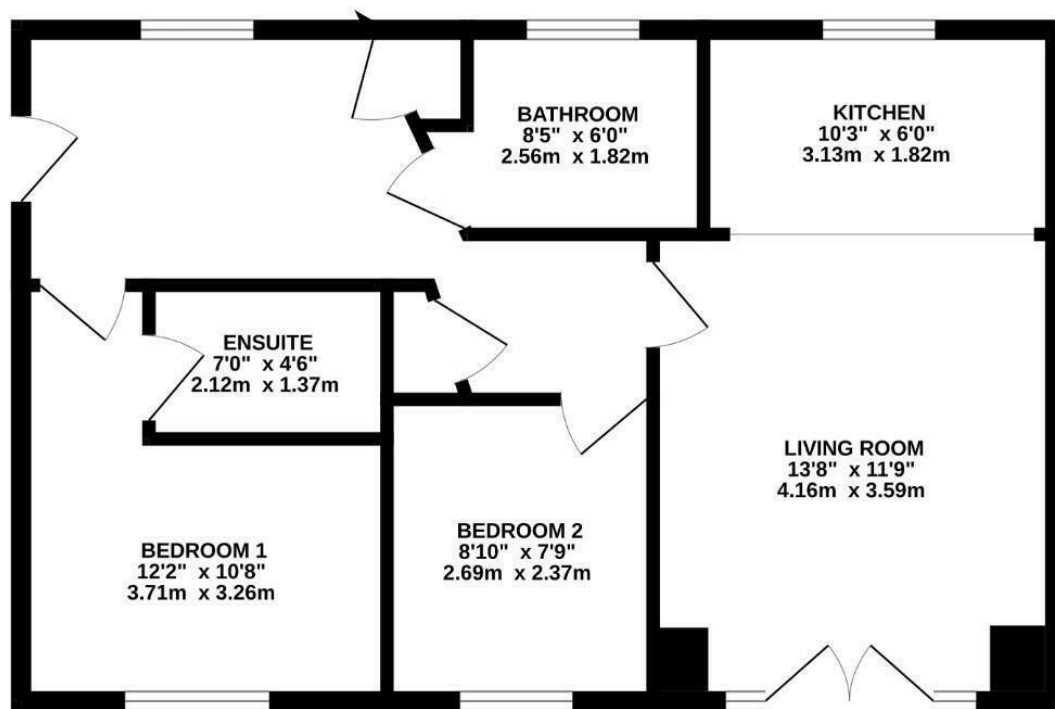
Tenure (Leasehold).
