### Tenure (Leasehold).

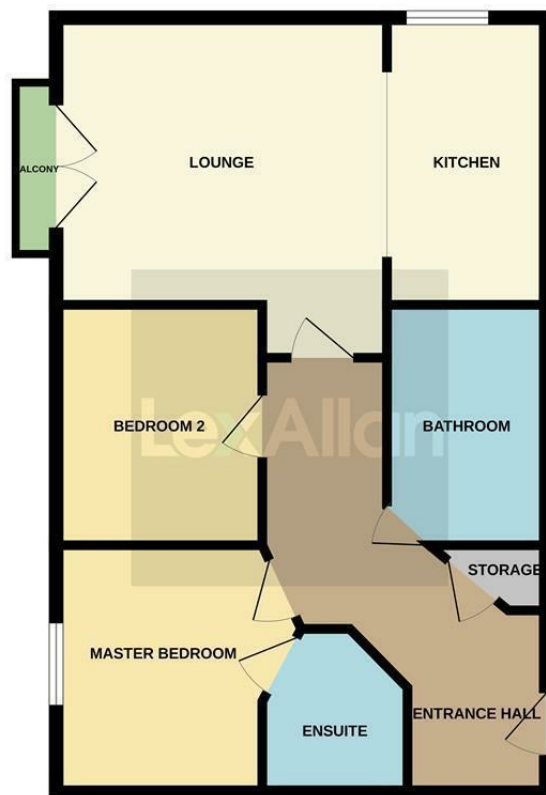
