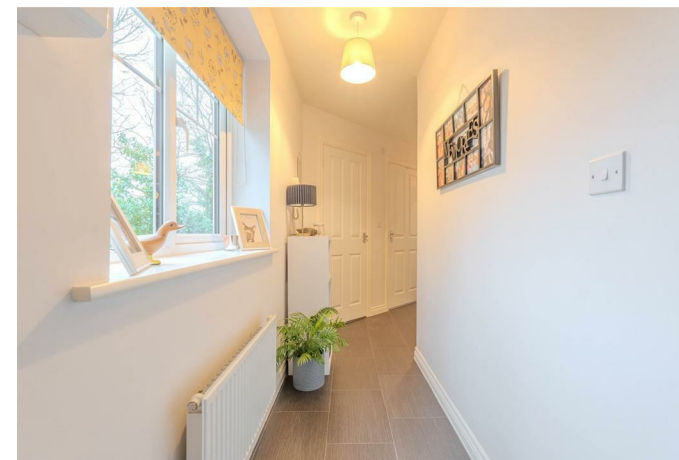

### Tenure (Leasehold).

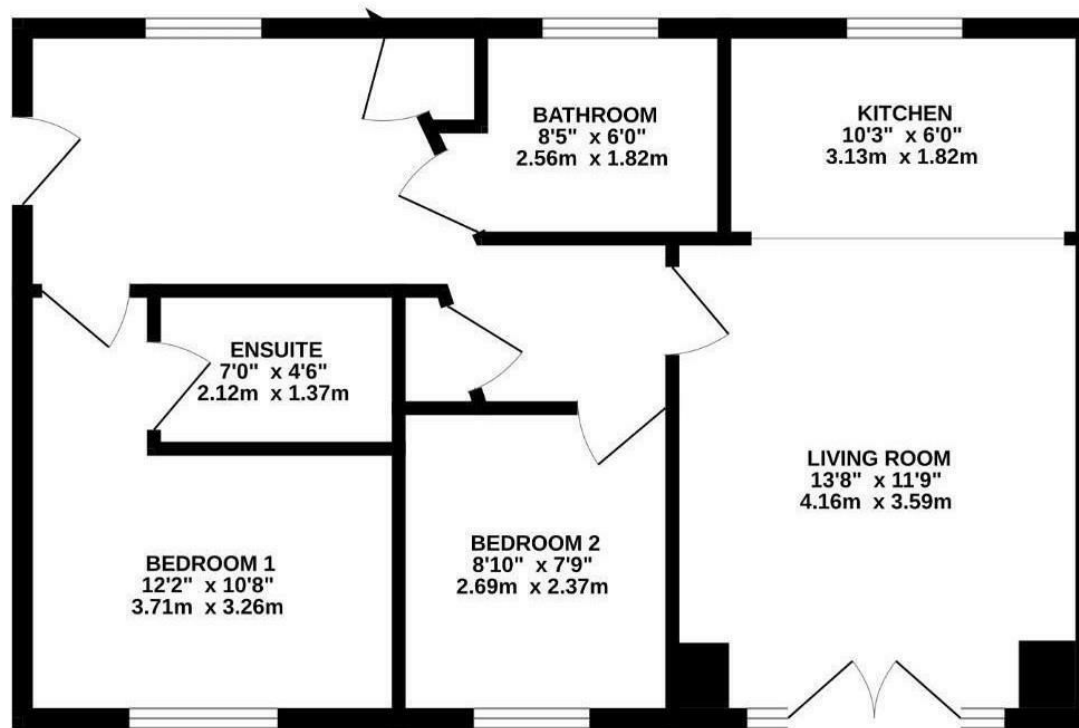

### Council Tax Band A



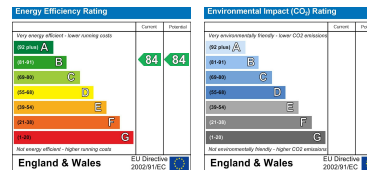
