Entrance Hall

Double glazed window to front and side, door to front, central heating radiator, tiled floor, stairs and cupboard off.

Lounge

9'6" min 11'5" max x 23'11" (2.9 min 3.5 max x 7.3)

Double glazed window to front and rear, double glazed door to rear, central heating radiator and gas fire.

Kitchen

7'10" x 10'5" (2.4 x 3.2)

Double glazed window to rear, double glazed door to side, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, integrated oven and dishwasher.

Double glazed window to side, access to loft space and doors off.

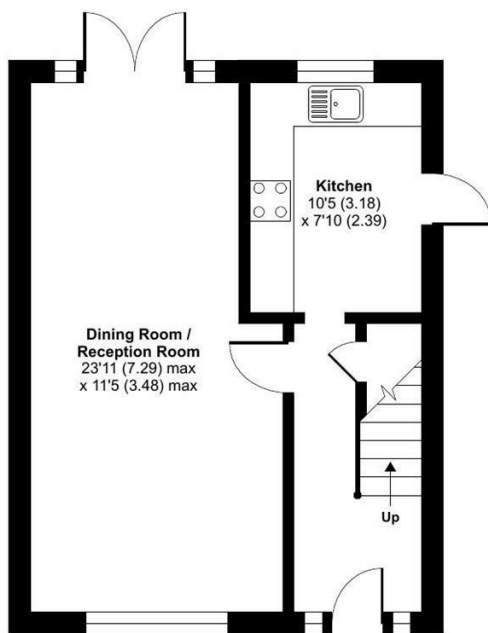

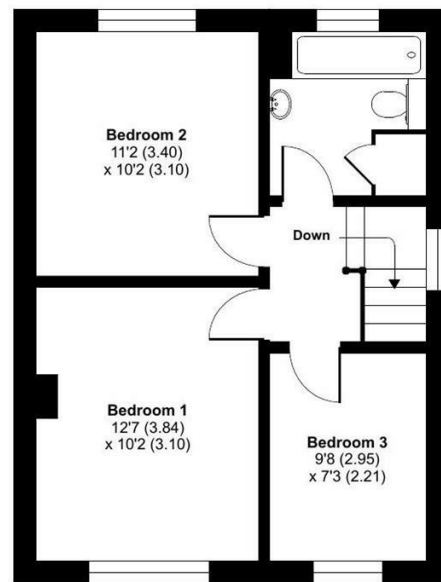

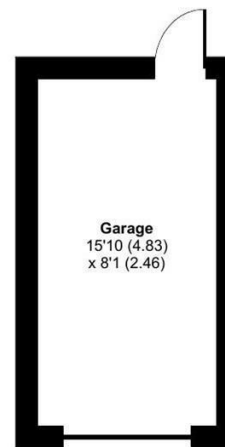
