In brief the property comprises; communal entrance, entrance hall, open planned lounge/kitchen/diner, master bedroom and shower room. Allocated parking can be found to the rear of the property. Communal Entrance

Immaculate entrance hall with stairs rising to the third floor, access to lift, character throughout of the converted building.

Entrance Hall

Doors radiating off, intercom, large under stair storage cupboard, electric heater, exposed beam.

Lounge/Diner/Kitchen
20'3" x 18'6" (6.18 x 5.64)

The heart of the home is this open planned living area with two double glazed picture windows with far reaching views of the canal and Redcone, exposed brick wall with exposed beams and vaulted ceiling. The kitchen offers a variety of a wall and base units with multiple integrated goods that include, dishwasher, fridge/freezer and washing machine, inset sink and drainer, electric oven and hob with extractor above, spot lights and electric heater.



Master Bedroom 20'4" x 19'0" (6.21 x 5.80)

A superb sized master bedroom with two skylights with fitted blinds letting the natural light flood in, exposed beams run throughout the room along with electric heaters.

Shower Room

Tenure (Leasehold).

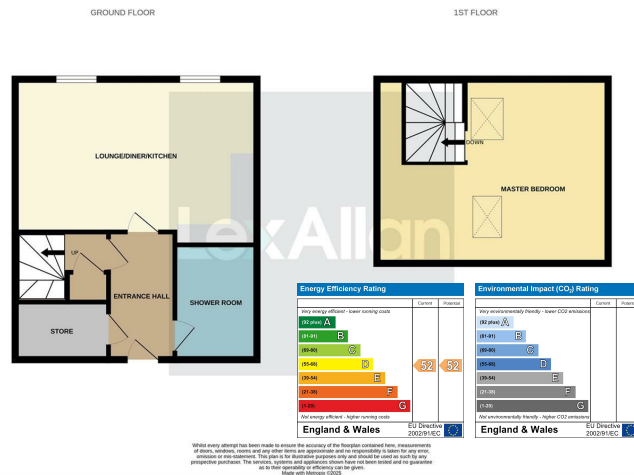
