**Approach**

Block paved drive to front providing off road parking

**Kitchen**

Variety of wall and base units, electric oven with hob and extractor above, plumbing for washing machine, dishwasher, tiled flooring, sink and drainer, access leading to the side of the property, sky light.

**Lounge**

Log burner with hearth, double glazed window to front, central heated radiator, opening to the dining room.

**Dining Room**

French doors opening up onto the decked area, central heated radiator, stairs rising to first floor.

**Bedroom 1**

Double glazed window to rear, central heated radiator.

**Bathroom**

Bath with shower over, wash hand basin, w.c, spot lights, double glazed window to side, central heated towel rail.

**Bedroom 2**

Two sky lights, spot lights.

**Bedroom 3**

Storage into the eaves, sky light, spot lights.

**Rear Garden**

Decked area along with a neat and today lawn, side access to the front of the property.

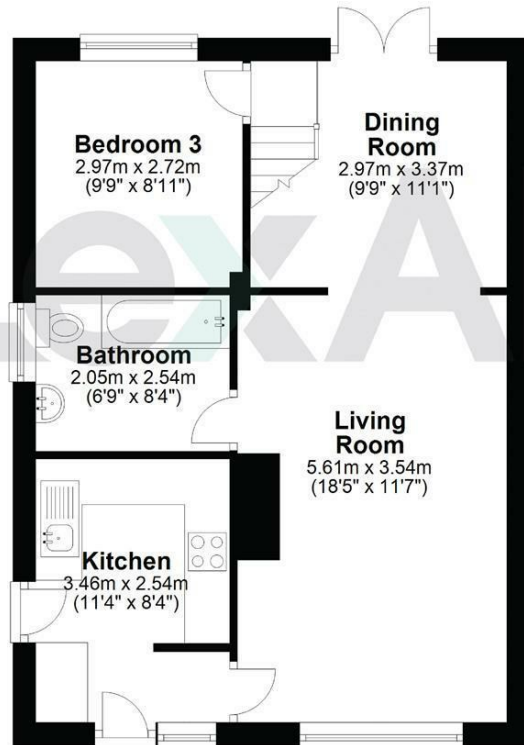






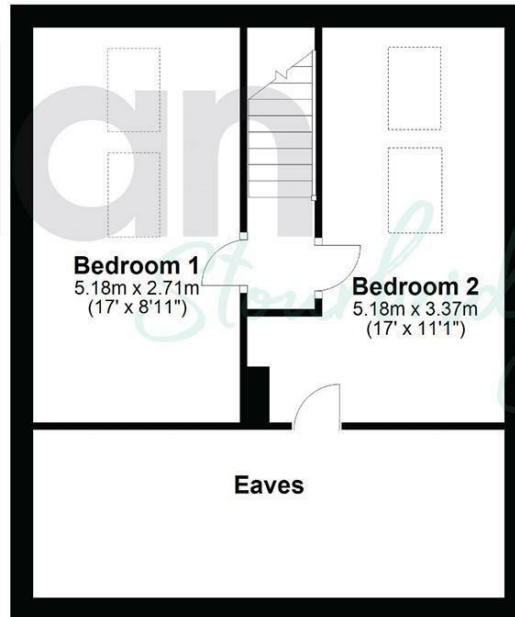
### Ground Floor
