Slabbed pathway to front with mature shrub.

**Entrance Hall**

Doors radiating off, stairs rising to first floor, central heated radiator.

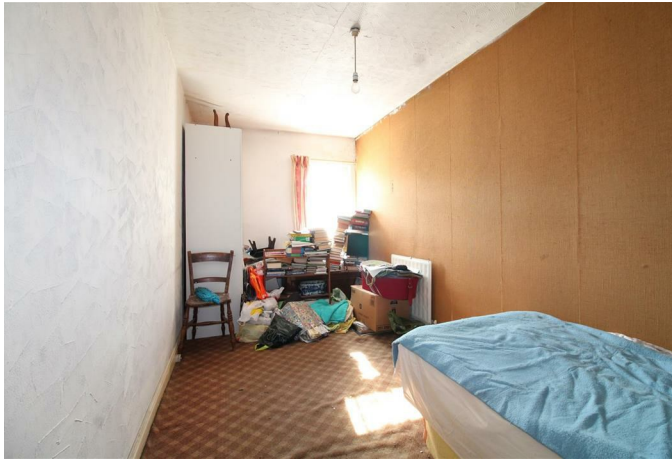

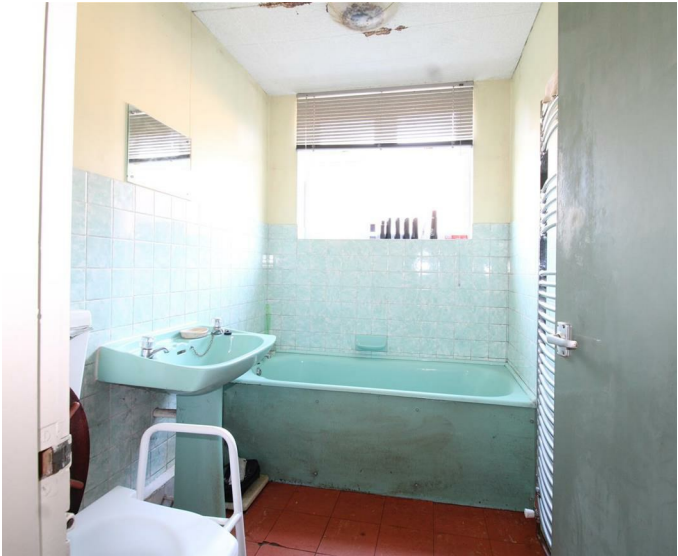
