Tarmac drive offering parking for a number of cars, access to side.

Hallway

Double glazed window and door to side, central heating radiator and stairs off.

Lounge

11'5" x 16'0" (3.5 x 4.9)

Double glazed window and door to conservatory and central heating radiator.

Conservatory

9'6" x 12'1" (2.9 x 3.7)

Double glazed windows and door to side, tiled floor.

Kitchen

Double glazed window to front, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, integrated oven, space and plumbing for washing machine and tiled splash backs.

Garage

Electric roller door to front.
