Gravelled driveway to front.

#### Entrance Hall

Stairs rising to first floor, door off to lounge.

#### Lounge

13'0" x 11'11" (3.96 x 3.62)

Double glazed bay window to front, under stair storage, central heated radiator.

#### Kitchen/Diner

15'6" x 11'11" (4.73 x 3.62)

Variety of wall and base units, Electric oven, four ring gas hob, integrated white goods including dishwasher, fridge and freezer, sink and drainer, double glazed window to side and rear, door access leading rear garden, tiled flooring, central heated radiator.

### The Location

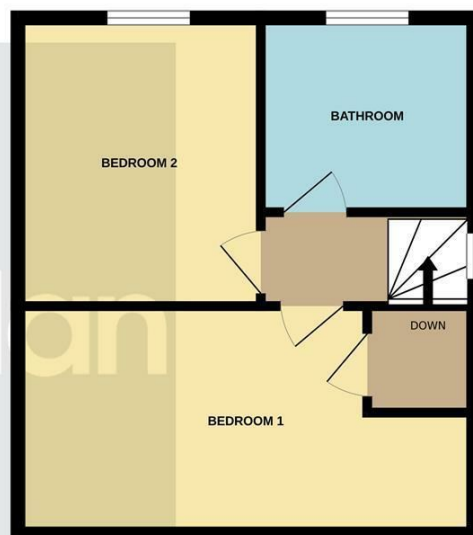




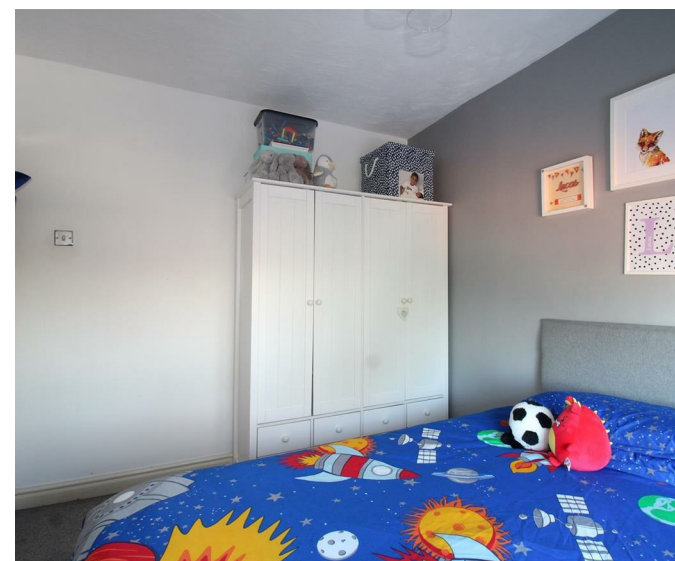
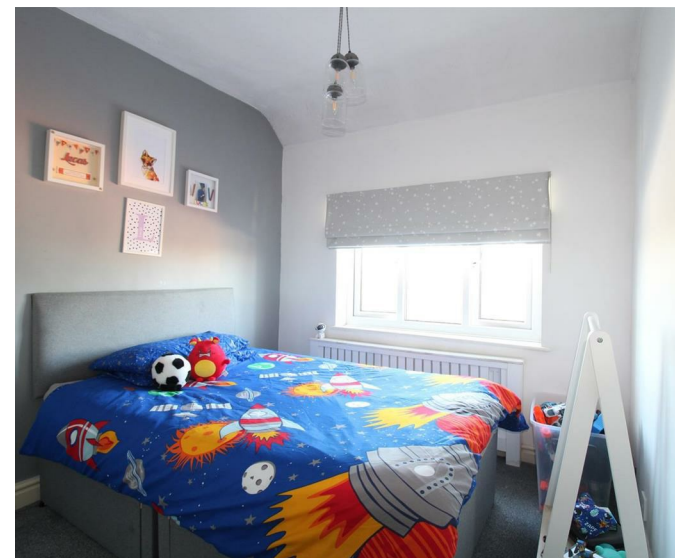
GROUND FLOOR
