### Entrance Hall

Tiled floor, double glazed door and window to front.

### Lounge

Double glazed window to front, electric fire with feature surround and central heating radiator.

### Conservatory

10'9" x 9'6" (3.3 x 2.9)

Double glazed windows and doors.

### Kitchen

9'10" x 11'1" (3.0 x 3.4)

Double glazed window to rear, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, integrated oven, microwave, dishwasher, fridge, breakfast bar, tiled floor and splash backs, fan heater, cupboard off and door to side.

Central heating radiator.

Metal up and over door to front.

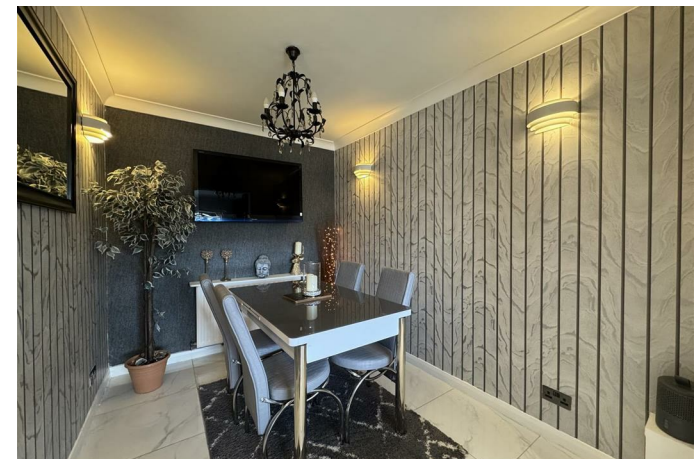
### Landing

Double glazed window to front, bath with mixer tap, heated towel rail, shower, WC, wash hand basin with mixer tap and storage below, tiled floor and splash backs and extractor fan.

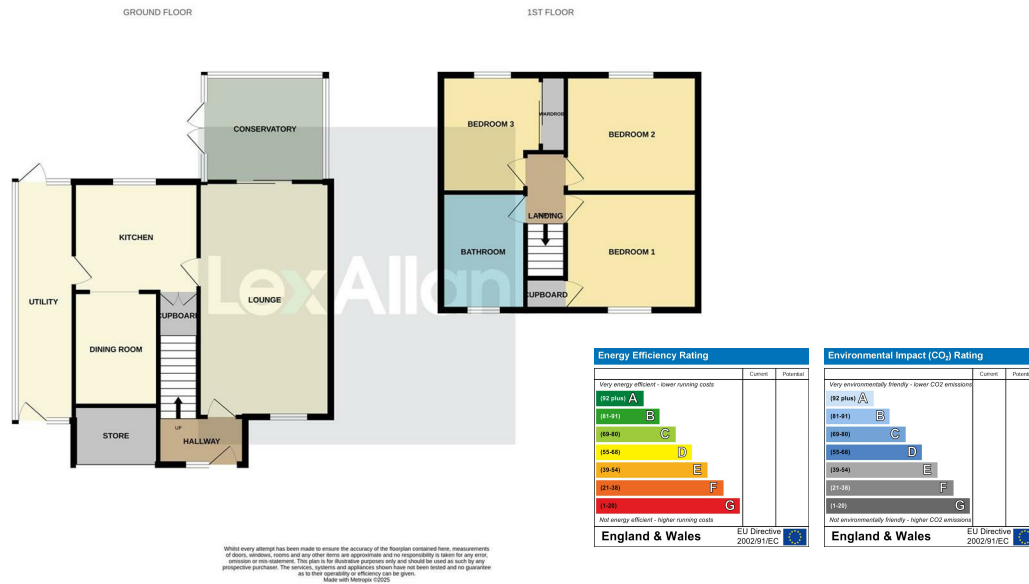
**Tenure (Freehold).**
