Tarmac driveway offering parking for a number of cars.

Porch

Door to front and central heating radiator.

WC

Double glazed window to front, WC, wash hand basin with mixer tap, tiled splash backs and central heating radiator.

Lounge

12' 1" min 15' 5" max x 15' 1" (3.7 min 4.7 max x 4.6)

Double glazed window to front, central heating radiator and stairs off.

Kitchen

15' 1" x 10' 9" (4.6 x 3.3)

Double glazed window and double doors to rear, cupboard off, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, integrated dishwasher, oven, fridge, freezer, washing machine, tiled floor and splash backs.

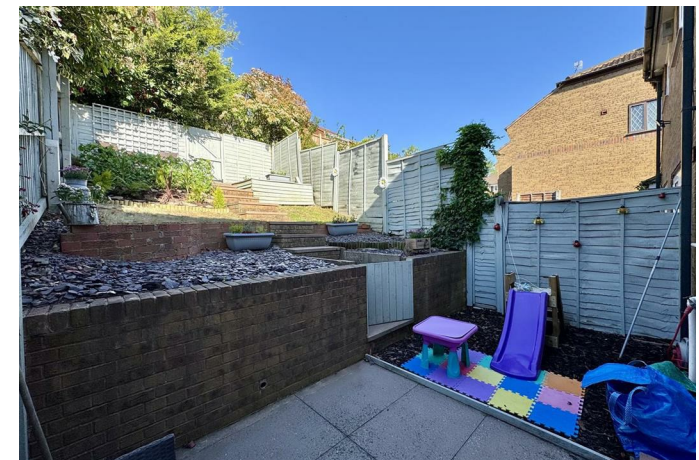
