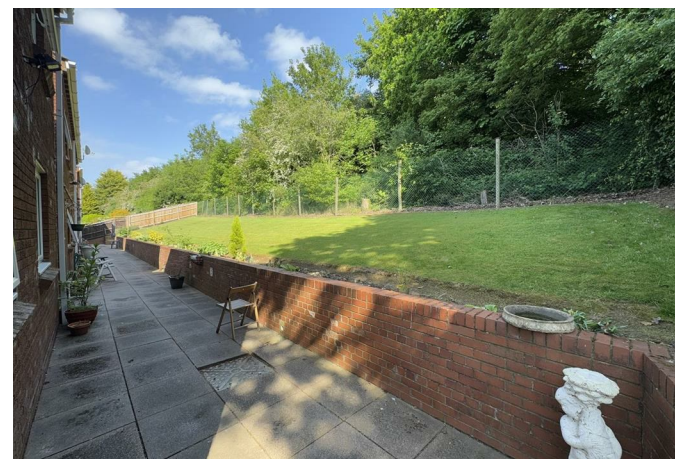

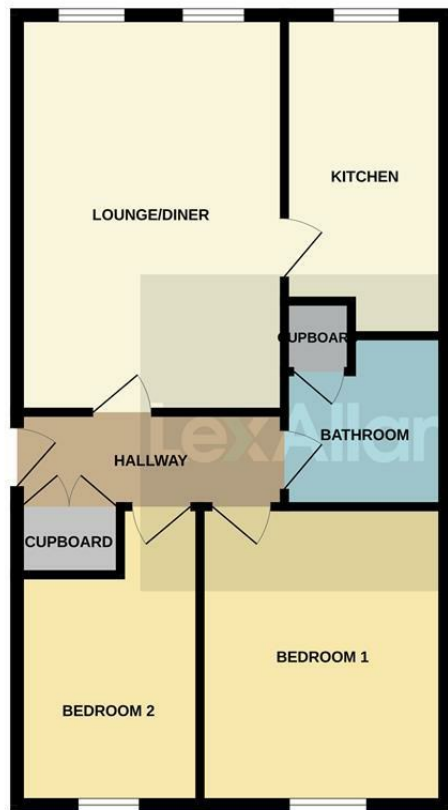
Tenure (Leasehold).
