Approach

Driveway to front, lawn, flowerbeds and gated side access.

Porch

Door to side, double glazed windows and tile flooring.

Entrance Hall

Central heating radiator and stairs off.

Lounge

Double glazed window to front and central heating radiator.

Kitchen

8'6" x 14'9" (2.6x4.5)

Double glazed windows to rear, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, integrated oven, space and plumbing for washing machine, integrated dishwasher, central heating radiator and tiled splash backs.

Storage cupboard off and door to side.

Double glazed window to side, WC with built in sink and central heating radiator.

Double glazed window to side, access to loft space and doors off.

10' 5" max 7' 2" min x 6' 10" (3.2 max 2.2 min x 2.1)

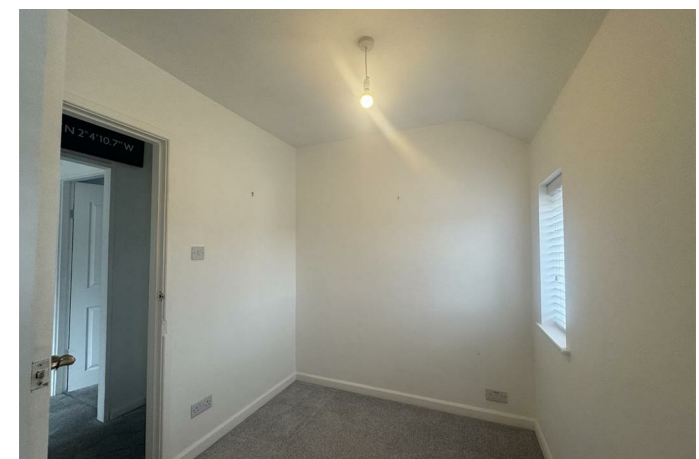
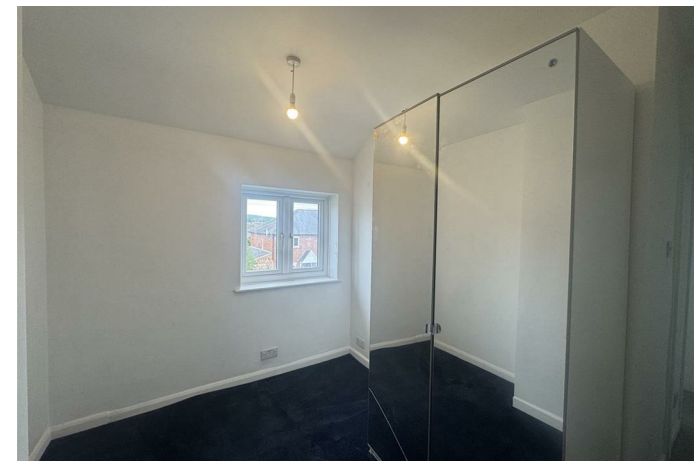
Double glazed windows to front and central heating radiator.

Bathroom

Double glazed window to side, wash hand basin with mixed tap over and storage below, WC, bath with mix tap and shower unit over, heated towel rail, extractor fan and tiled floor and splash backs.

Rear Garden

Patio area, pathway, lawns, flowerbeds with mature shrubs, shed and with fencing to enclose.

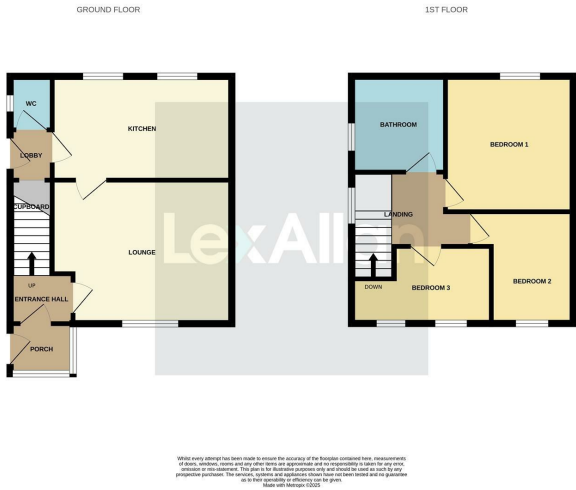
