### Approach

Block paved drive offering parking for a number of cars.

### Porch

Double glazed window and door to side.

### Garage

8'2" x 14'9" (2.5 x 4.5)

Electric up and over door to front.

### Lounge

10'9" x 15'1" (3.3 x 4.6)

Double glazed window to front and central heating radiator.

### Kitchen/Diner

8'6" x 18'8" (2.6 x 5.7)

Double glazed window to rear, sliding door, range of wall and base units with work surface over incorporating sink with mixer tap, electric hob with extractor hood over, integrated oven, tiled splash backs, integrated dishwasher, washing machine, fridge and freezer.

### Conservatory

9'10" x 11'9" (3.0 x 3.6)

Double glazed windows and door and tiled flooring.

### Landing

Access to loft space and doors off.

### Bedroom One

9'6" x 11'9" (2.9 x 3.6)

Double glazed window to front, central heating radiator and fitted wardrobe.

### Bedroom Two

9'10" x 10'5" (3.0 x 3.2)

Double glazed window to rear with far reaching views and central heating radiator.

### Bedroom Three

8'6" x 8'6" (2.6 x 2.6)

Double glazed window to front and central heating radiator.





**Bathroom**

Double glazed windows to rear, shower, WC, wash hand basin with mixer tap, bath with mixer tap, tiled floor and splash backs and heated towel rail.

**Rear Garden**

Patio area, lawn and all with fencing to enclose.

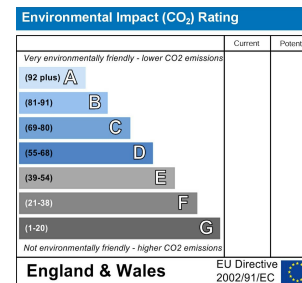
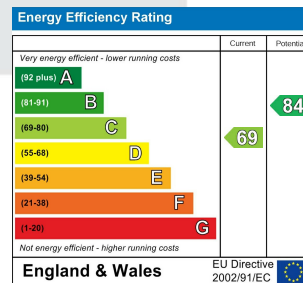
