**Approach**

Slabbed path leads access to the secure communal entrance.

**Communal Entrance**

Well maintained secure hall with stairs rising to the first floor, door to the rear allows access to the communal garden.

**Entrance Hall**

Spacious hall with doors off to all accommodation, three spacious storage cupboards, central heated radiator.

**Lounge/Diner**

## Referral Fees.


