

## The Property

Located within a stunning, characterful Victorian manor house, this three storey, two bedroom first floor apartment offers a wealth of charm within walking distance of Altrincham Town Centre. The building boasts a stunning architecture including a grand entrance hall with original oak panelling and stained glass windows, as well as manicured grounds with allocated parking and sweeping drive way which are set behind electric gates.

The apartment offers an entrance hall with understairs storage and staircase leading to the main landing hall with large sky lantern offering an abundance of natural lighting. From there, you can access the lounge with triple floor to ceiling windows overlooking the grounds and car park area. Additionally there is the kitchen diner with range cooker and stained glass and leaded port window. There are also two double bedrooms and a four piece family bathroom suite including shower cubicle and bath.

A unique selling point of this property is the spiral staircase built within the original turret which leads onto a private roof terrace overlooking the grounds of the property.


