A communal front garden opens into the main lobby and this apartment is located to the ground floor. The private front door opens into the apartment's hallway that gives access to all rooms. The open plan kitchen living room has dual aspect making it feel bright and inviting, and has patio doors that lead onto a patio terrace to the rear. The kitchen fittings are modern with a good range of storage units above and below the worktop, with a gas hob, oven, extractor fan, and fridge freezer built in. The

bedrooms are both doubles with large windows, with the main bedroom having the added benefit of an ensuite shower room. The contemporary family bathroom is located central to the apartment and has a panel bath, shower, shower screen, handbasin, WC, and a heated chrome towel rail. Opposite this are two storage cupboards, one of which houses the gas boiler and has plumbing for a washing machine. Externally, there is allocated car parking for one car, and well maintained communal gardens.



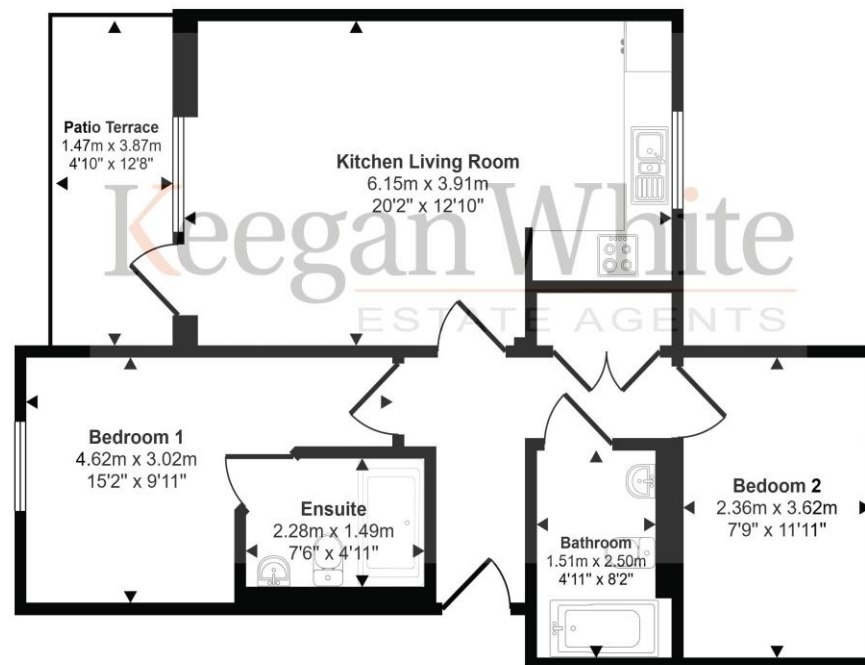
