



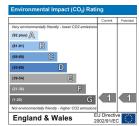
Area Map
