**LOCATION**

With over 40,000 inhabitants including nearby villages, Barnstaple is a thriving town near to beautiful beaches and countryside, and the centre of North Devon in commerce, culture, education and service provision. It has a wide variety of businesses attracting tourists and permanent residents year-round, including a vibrant and diverse collection of bars and restaurants for evening footfall. Barnstaple is easily reached via the A361 which leads to the M5 at Junction 27, has a station with hourly trains to Exeter at peak times, and Exeter airport is an hour away. The town is rapidly expanding with several new housing and commercial developments currently underway, and more than 5,000 new houses and further economic development planned for the near future. The notable towns of Bideford (9 miles), Woolacombe (14 miles), Ilfracombe (12 miles), South Molton (12 miles) and Torrington (14 miles) are also nearby.

**THE SITUATION**

The subject property is situated on the entrance to the Town's High Street and benefits from a double frontage. There are assorted retail, office and leisure users in the immediate vicinity including Tesco Express, Halifax and HSBC as well as many strong independent retailers.

## ACCOMMODATION

The property comprises a ground floor lock up shop with two storey ancillary accommodation above. The ground floor shop has a suspended ceiling, wood effect flooring and staff WC to the rear. The first floor comprises two large storage/ office areas and kitchenette. This space could also be used for additional sales area. The second floor provides additional storage/ office space and WC.
