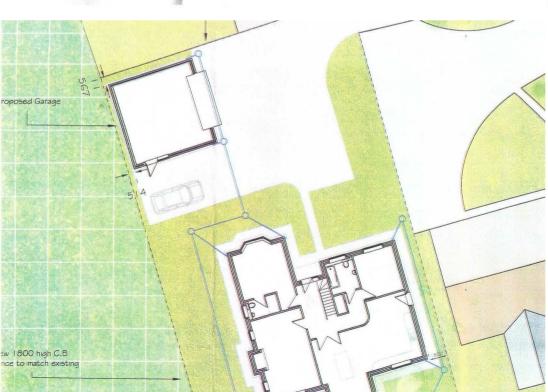






ALL WINDOWS AND DOORS TO BE CASEMENT PVCU DOUBLE GLAZED
