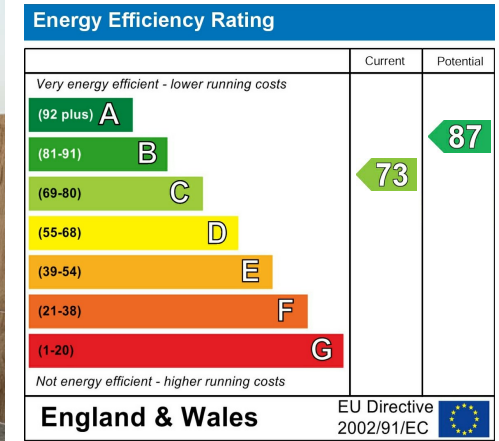

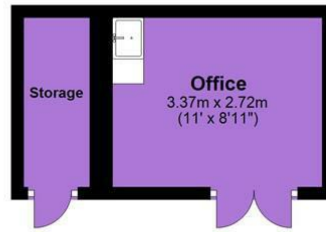


## EPC Chart
