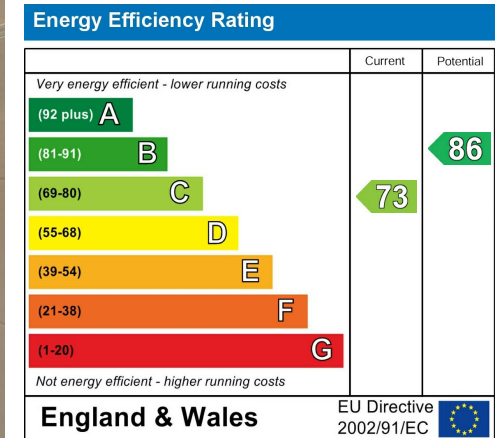

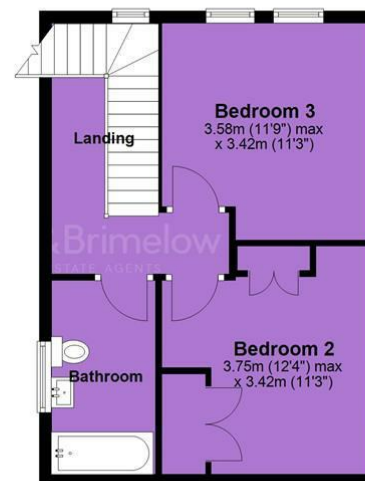
Ground Floor
