MODERN DUPLEX APARTMENT WITH 3 DOUBLE BEDROOMS, flexible accommodation over two levels. Situated with good access to Halifax Town Centre the property is centrally heated and double glazed and has accommodation briefly comprising communal entrance door to personal entrance door, hallway, lounge, dining kitchen with appliances including four ring gas hob, electric oven and extractor, double bedroom and house bathroom. To the second floor are two further double bedrooms and shower room. Outside there is a parking space.





### Entrance Hallway

Having a double glazed window, two central heating radiators and two storage cupboards.

### Lounge:

18'9" x 13'8" (5.72 x 4.17)

Being of generous proportions and having two double glazed windows and a central heating radiator.

### Breakfast kitchen:

13'0" x 12'6" (3.96 x 3.81)

Having wall and base units with working surfaces over, there is a breakfast bar, 1 1/2 stainless steel sink with side drainer and mixer tap, a wall mounted boiler, space and plumbing for automatic washing machine, 4 ring gas hob with cooker hood over and oven beneath, two double glazed windows and a central heating radiator.

### Bedroom Three:

13'4" x 9'4" (4.06 x 2.84)

Having a double glazed window and a central heating radiator.

### Bathroom:

Comprising of a three piece suite incorporating a bath with shower over, low flush WC and a hand wash basin. There is a central heating radiator and a double glazed window.

Having a useful storage cupboard.

#### Bedroom One:

12'0" x 12'0" with reduced head height (3.68 x 3.66 with reduced head height)

Having two Velux windows and a central heating radiator.

#### Bedroom Two:

12'4" x 12'2" with reduced head height (3.76 x 3.73 with reduced head height)

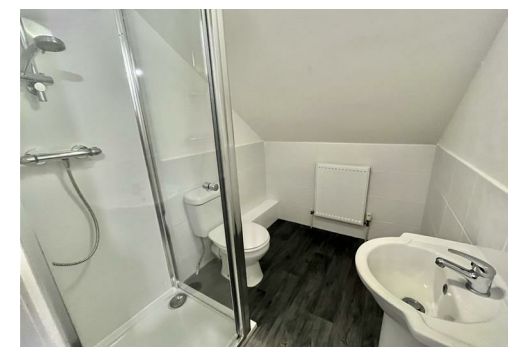
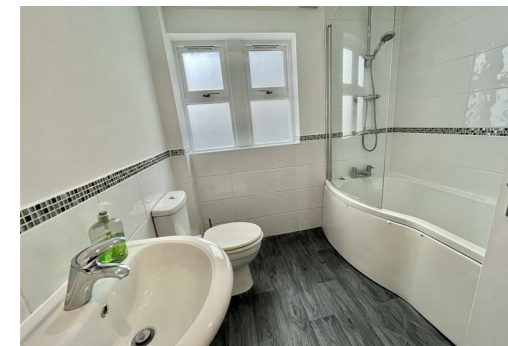
Having two velux windows and a central heating radiator.

3 piece suite in white comprising shower cubicle, wc and sink unit.

### BOUNDARIES & OWNERSHIPS:

Please Note: The developers of Beverley Place have informed us that once the site is complete, they will transfer the freehold title to the management company and the shares in the management company will be passed on to the apartment owners on an equal basis. In this way the apartment owners will control both the freehold title and the management company. By owning the management company, the apartment owners will then control the running of the site, including the expenditure on it and the setting and collection of the service charge.

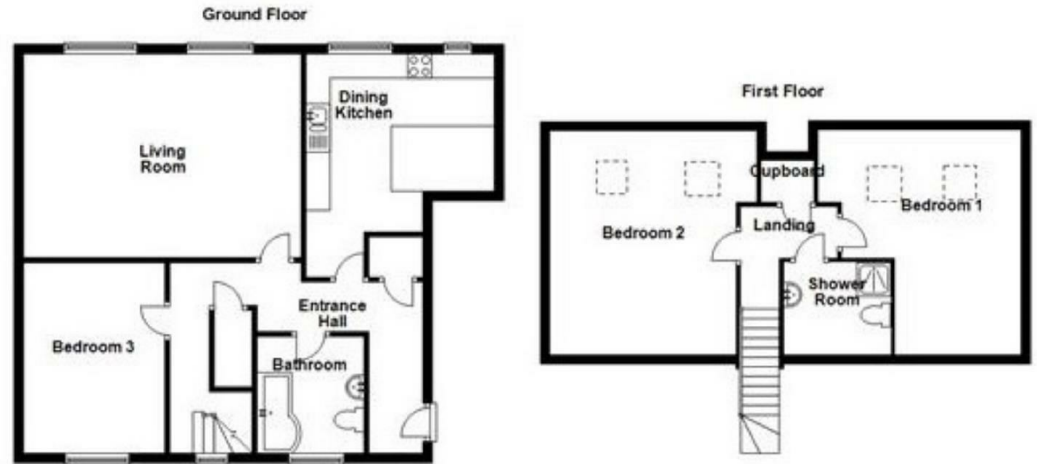
