The property is conveniently located, at the end of a popular cul-de-sac development, within easy walking distance of the River Wensum and the Town Centre.

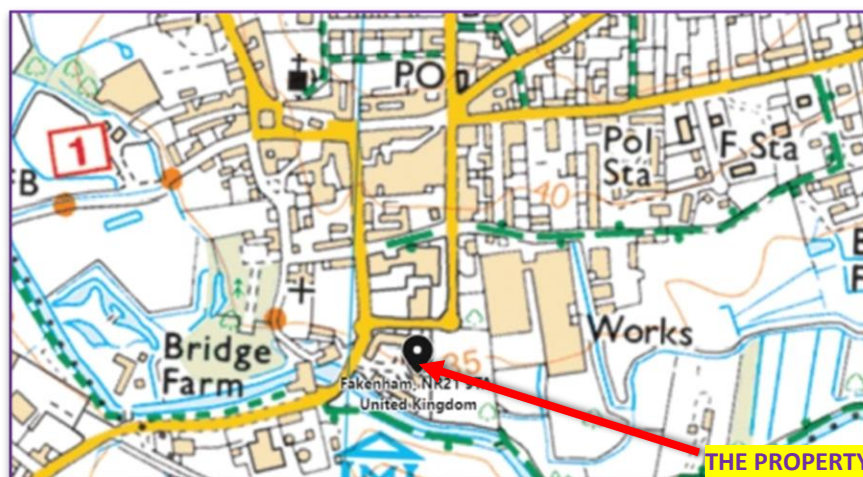
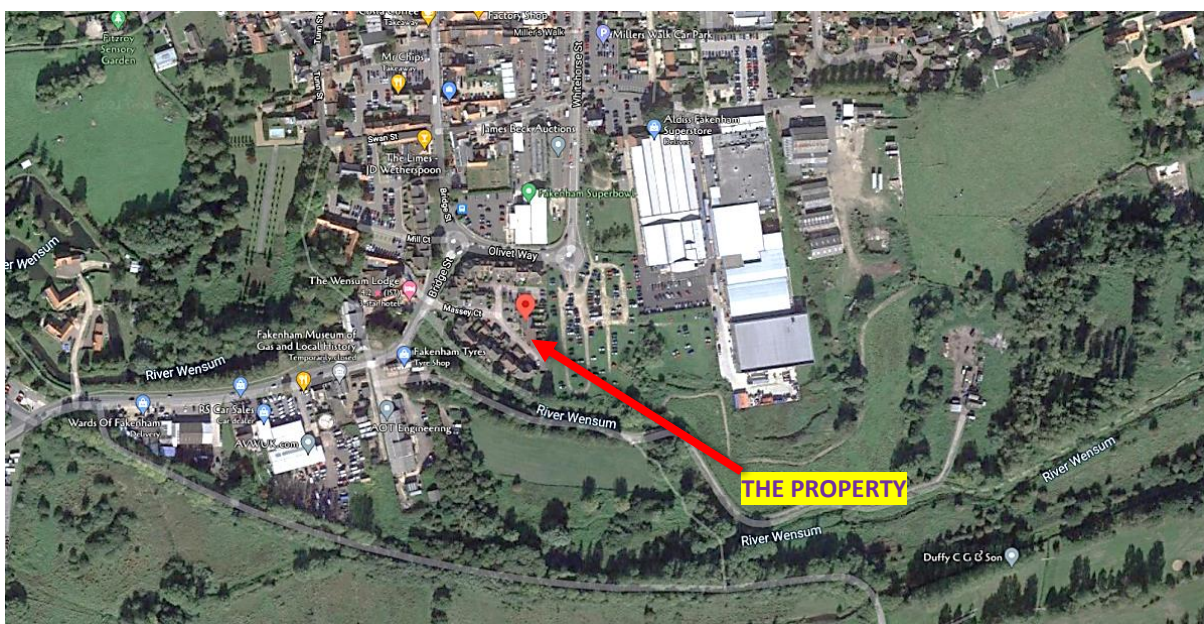

Ground Floor:

Half double glazed door to;

Entrance Hall: Telephone point. Staircase to first floor.

Cloakroom: Low level WC. Pedestal hand basin with tiled splashback.

Bay fronted Sitting room: 15'5" x 11'0", (4.7m x 3.4m) into bay. Living flame gas fire with marble surround, mantle shelf and hearth. Understairs cupboard. 2 centre lights and 2 wall lights. TV point. Double folding doors to;

Kitchen/Breakfast room: 14'2" x 8'8", (4.3m x 2.7m). Sink unit with pedestal mixer tap, set in fitted work surface with tiled splashback, and cupboards, drawers, appliance spaces and plumbing for washing machine under. Built-in 4 ring gas hob unit with oven under and extractor hood over. Matching range of wall mounted cupboard units with adjoining shelves. Wall mounted gas fired central heating boiler. Strip light. Tiled floor. Twin double glazed doors with fitted roller blinds to rear garden.

Landing: Airing cupboard with factory lagged hot water cylinder, fitted immersion and slatted shelving. Hatch to roof space.

Bedroom 1: 12'1" x 9'6", (3.7m x 2.9m). Built in double wardrobe cupboard with folding mirror doors.

Bedroom 2: 11'5" x 8'0", (3.5m x 2.4m). Open view to rear.

To the rear is a further, very well enclosed Garden with lawn, flower borders, and a paved path leading to a paved patio area and timber and felt roofed **Garden Store** 7'0" x 5'0", (2.1m x 1.5m).

To the side of the property is a brick,, timber and tiled **Double Car Port**, 17'5" x 17'0", (5.3m x 5.2m), with electric light, power points, concrete floor, and a pedestrian gate leading into the rear garden.
