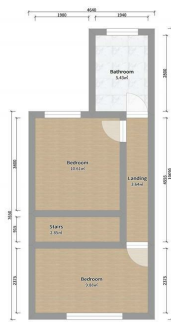

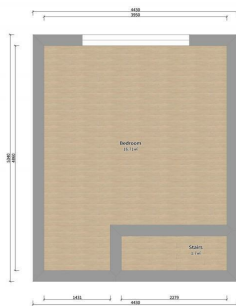

Warwards Lane First Floor

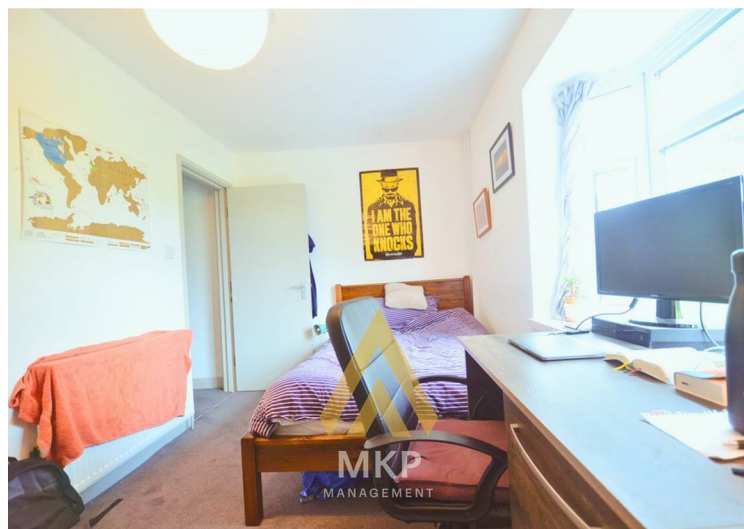
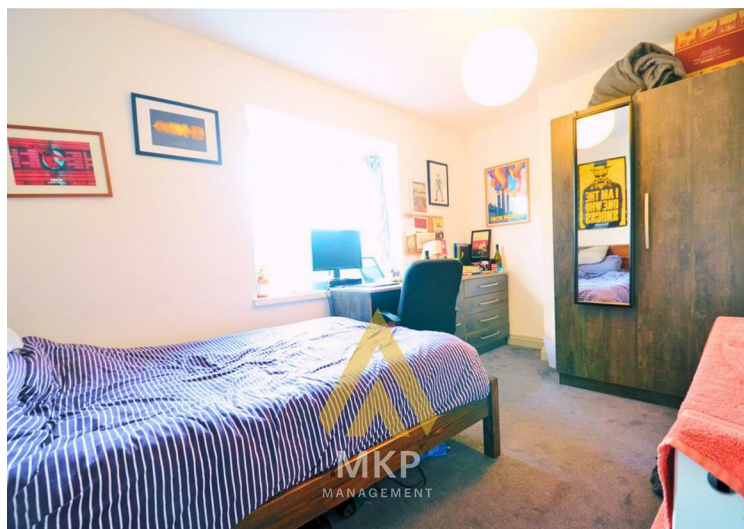
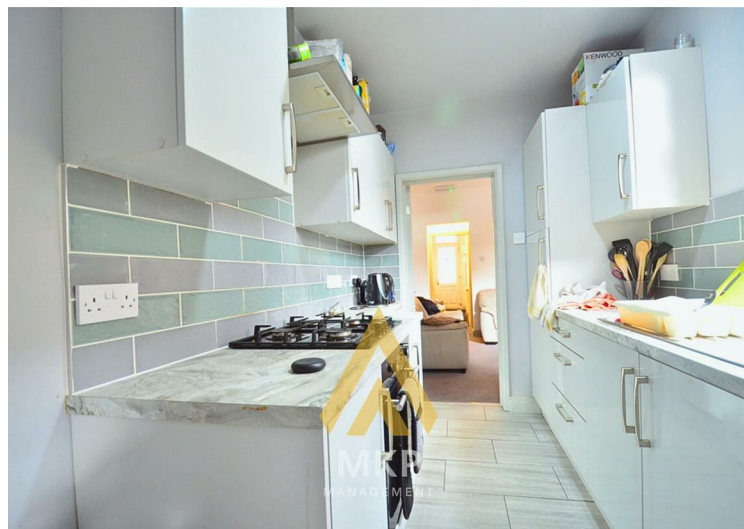


Warwards Lane Second Floor
