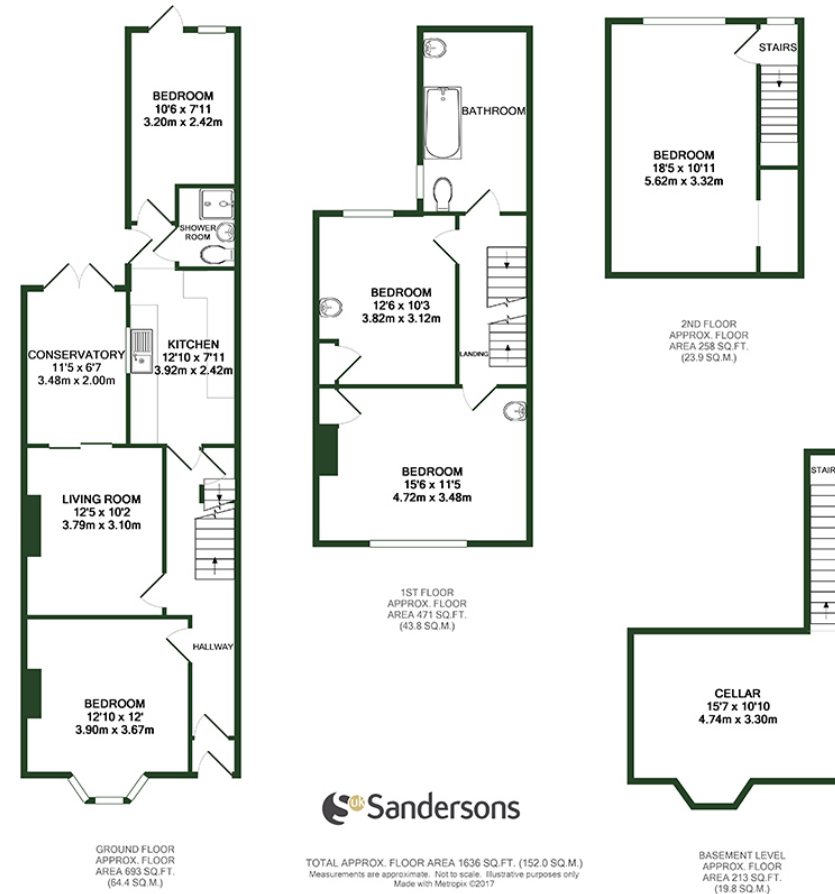


The Property

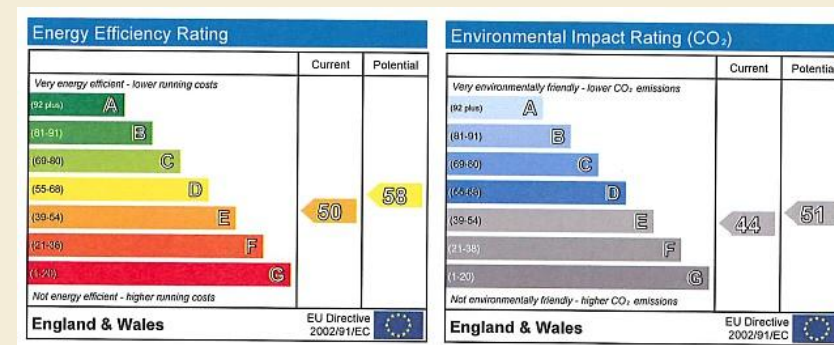
