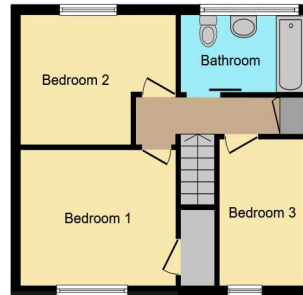

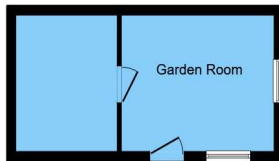
## Floorplan
