About the property

A well presented three-bedroom, semi-detached bungalow for sale with no on-going chain.

Benefiting from attractive views, a front and rear garden, off road parking and a garage. Situated within a sought-after cul-de-sac location with public transport links, local schools, and shops all within close proximity.

Internally the property comprises of an entrance hall with a double storage cupboard, a spacious lounge with a bay window, a kitchen, three spacious bedrooms and a bathroom. The front of the property features a generous size lawn and driveway with access into the garage. The rear garden offers a private space comprising of both patio and artificial lawn.

Entrance Hall

Entrance via a upvc door with a upvc panel. Fitted carpets and a double storage cupboard with doors leading to the lounge and kitchen.

Lounge

Fitted carpets, a gas fireplace and upvc bay windows to the front.

Kitchen

12' 6" max x 12' 7" max (3.81m max x 3.84m max)

Fitted with a matching range of wall and base units with worktop space over and a stainless steel sink with a mixer tap. Space for a cooker, fridge freezer and washing machine. Tiled splashbacks and vinyl flooring. Upvc windows to the front and rear. Upvc door to the side and a door into the inner hall.



Inner Hall

Fitted carpets, access to the attic and built in storage cupboard. Doors into the kitchen, three bedrooms and a bathroom.

Bedroom One

14' 1" x 9' 6" max not including wardrobes (4.29m x 2.90m max not including wardrobes)

Fitted carpets, fitted wardrobes and a upvc window to the rear.

Bedroom Two

10' 6" max x 9' 3" max (3.20m max x 2.82m max)

Fitted carpets and upvc double doors to the rear.

Bedroom Three

10' 8" x 6' 2" (3.25m x 1.88m)

Upvc window to the rear.

Bathroom

Fitted with a three-piece suite comprising of a bath with a shower over, a w.c and wash hand basin. Vinyl flooring and tiled walls. Upvc window with obscured glass to the side.

Front

Access onto the driveway and front lawn with access into the garage.

Rear

Patio area with steps leading to two tiers, comprising of artificial lawn, patio and mature shrubs.
