About the property

Internally the property comprises of a living room, kitchen/diner, conservatory and bathroom to the ground floor. To the first floor there are three/four bedrooms and stairs to the attic room.

The rear of the property features an enclosed space laid to patio and outbuilding which is plumbed for a utility room.
