# About the property

Available with no chain is this spacious three/four bedroom home, located in the popular village of Cwmavon within close access to local amenities. The property benefits from living room with bay window to front, dining room, kitchen, cloakroom and bathroom to ground floor. To the first floor there are three bedrooms, with the master being split by a partition wall and sliding door, making the possibility for a forth bedroom or playroom/dressing room. There is also a second family bathroom to the first floor.

Externally there is a small frontage with path to the front door, while the rear is low maintenance featuring a double garage with an inspection pit. Viewing is highly recommended to appreciate what is on offer.
