# About the property

A well presented three bedroom semi-detached property for sale with no on-going chain. Ideal first time buyers opportunity or family home, benefiting from three double bedrooms, two reception rooms, a modern kitchen with part fitted appliances, and a front and rear garden. Situated within the popular area of Cimla, with schools, shops and public transport links all within close proximity.

Internally the property comprises of an entrance hall, a lounge, dining room and kitchen to the ground floor. The first floor features three double bedrooms, ample storage, a bathroom and a separate w.c.

To the front of the property there is an enclosed low maintenance garden with side access via a gate. The rear garden also offers an enclosed space with part decking and patio.

Internal viewings come highly recommended.



## Accommodation

#### **Entrance Hall**

Entrance via a upvc door to the front. Fitted carpet, understair storage, stairs to the first floor, upvc window to the side and a door into the lounge.

#### Lounge

12' 6 " x 12' 7 " max (  $3.81\,m$  x  $3.84\,m$  max ) Fitted carpet, upvc window to the front - leading into dining room.

#### **Dining Room**

9' 2" max x 9' 2" max ( 2.79m max x 2.79m max ) Laminate flooring, upvc window to the rear, build in storage cupboard and a door into the kitchen.

#### **Kitchen**

9' 3" x 8' 9" ( 2.82m x 2.67m )

Fitted with a matching range of wall and base units with worktop space over and a sink with a mixer tap. Integrated cooker, hob, hood, fridge freezer, washing machine and dishwasher. Laminate flooring, upvc window to the rear and a upvc door with obscured glass to the side.

#### Landing

Fitted carpet to stairs and landing, access to the attic, upvc window to the side, build in storage cupboard housing a wall mounted gas combination boiler and doors into all three bedrooms, bathroom and w.c.

#### **Bedroom One**

11' 4"  $\max x$  10' 1"  $\min$  ( 3.45m  $\max x$  3.07m  $\min$  ) Fitted carpets, build in storage and a upvc window to the front.

#### **Bedroom Two**

12' 6" max x 9' 1" ( 3.81 m max x 2.77 m ) Fitted carpet, build in storage and a upvc window to the rear.

#### **Bedroom Three**

 $8'\ 7''\ x\ 7'\ 7''\ (\ 2.62m\ x\ 2.31m\ )$  Laminate flooring and a upvc window to the front.

#### **Bathroom**

Fitted with a two piece suite comprising of a bath with a mixer tap, shower over and glass screen and a wash hand basin with a mixer tap. Laminate flooring and tiled walls. Heated towel rail and a upvc window with obscured glass to the rear.

#### W.C

W.c and wash hand basin with mixer tap, laminate flooring and part tiled walls. Upvc window with obscured glass to the side.

#### **Front**


Gate to the front, lowering to garden space with side access via a gate.

Door into brick build storage shed. Patio and decking areas lowering to an area laid to chipping stones.
