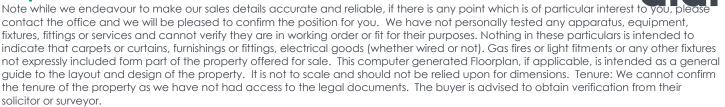


Floorplan
