About the property

Accommodation first comprises of an open hallway which in turn gives access to all rooms. The reception rooms are open plan to each other and provide ample space to comfortably accommodate a range of both seating and dining furniture. The ground floor family bathroom is fitted with a suite comprising of a WC, a wash hand basin and bath with shower attachment.
