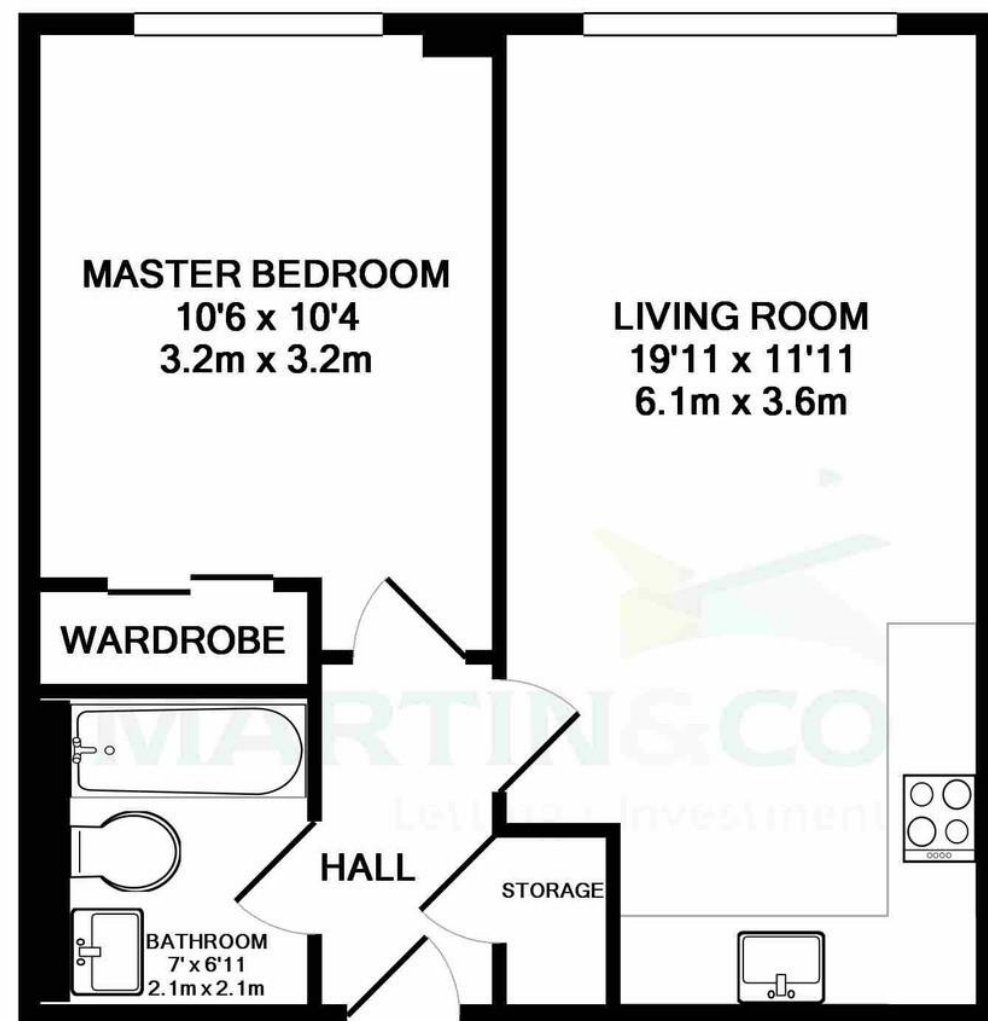

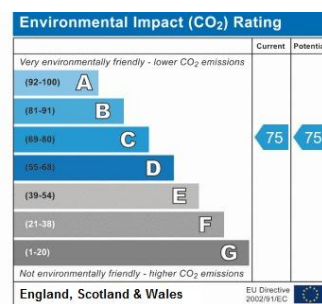
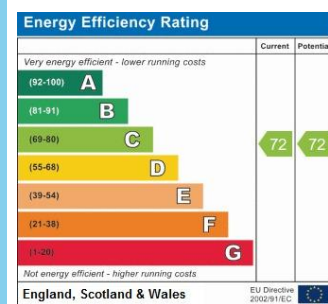

PARKING Allocated parking space located under the building
