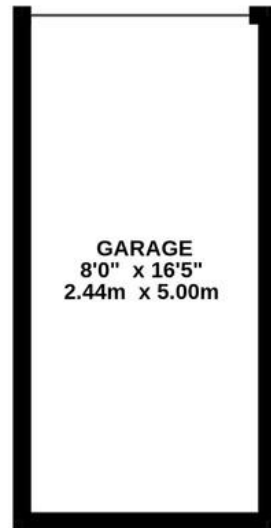
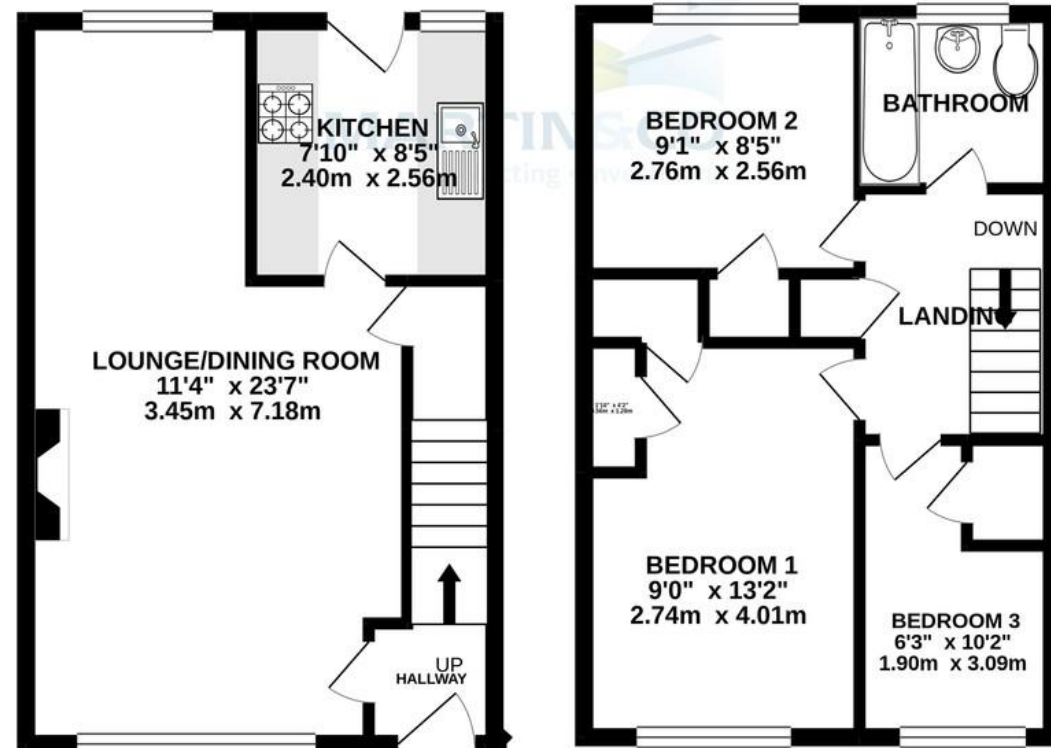

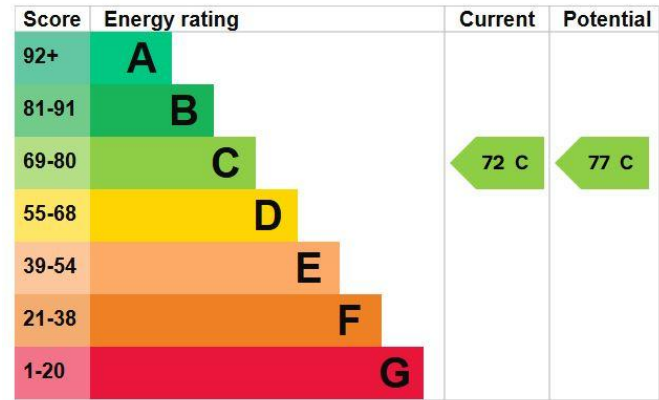

HALL Carpet, stairs to the landing and glazed door to the lounge.

LOUNGE/DINING ROOM 23' 6" x 11' 3" (7.18m x 3.45m) Front and rear aspect windows, feature fireplace, laminate floor, radiator, under stairs storage cupboard and door to the kitchen.

KITCHEN 8' 4" x 7' 10" (2.56m x 2.40m) Rear aspect window, a range of eye and base level storage units with rolled edge work surfaces, integrated oven, four ring gas hob with extractor hood over, under cabinet fridge & freezer, washing machine, tiled floor and door to the garden.



LANDING Carpet, loft access and airing cupboard.

BEDROOM ONE 13' 1" x 9' 0" (4.01m x 2.74m) Front aspect window, wardrobe, storage cupboard, radiator and laminate floor.

BEDROOM TWO 9' 0" x 8' 5" (2.76m x 2.57m) Rear aspect window, carpet, radiator and wardrobe.

BEDROOM THREE 6' 2" x 10' 1" Max (1.90m x 3.09m) Front aspect window, wardrobe carpet and radiator.

BATHROOM Rear aspect window, bath with shower over, low-level WC, wash hand basin, radiator and tiled floor.

OUTSIDE Parking, small enclosed rear garden, garden shed and access to garage with up and over door.

REFERENCES A holding deposit equivalent to 1 weeks rent will be required to reserve the property while referencing checks are being carried out.
