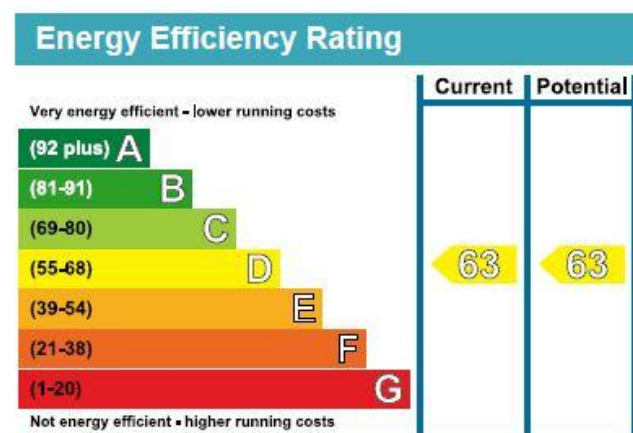

Reference Checks and Credit Worthiness
