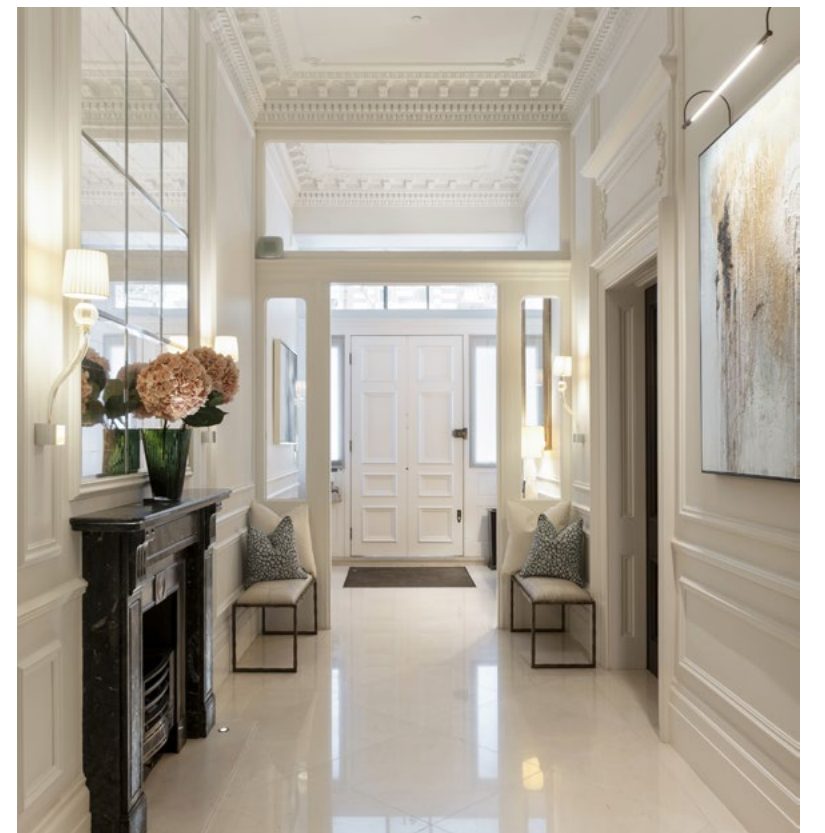
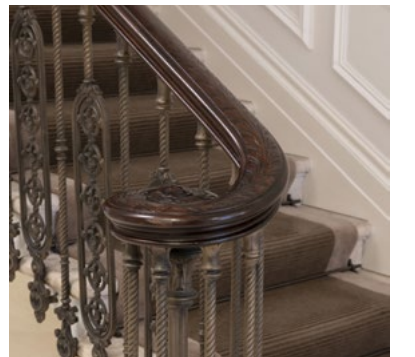
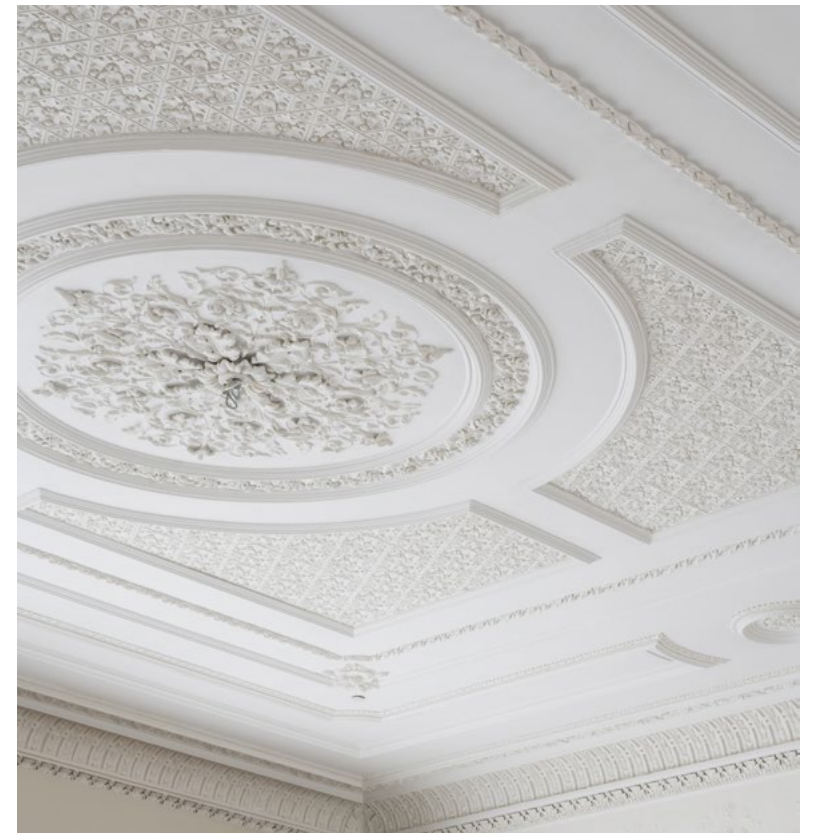
An immaculately presented, Grade II listed, mid-terrace house, constructed in the mid-19th century, with an adjoining two-bedroom mews house at the rear in South Kensington

This ten-bedroom residence provides a perfect balance of entertaining space, family accommodation and luxury amenities. The basement and lower ground floors feature extensive leisure facilities, including a swimming pool, steam room, sauna, gym, and cinema room.

The ground and first floors are dedicated to traditional formal reception spaces, while the upper floors provide bedroom suites and staff accommodation.

The mews house to the rear has an additional two bedrooms and is arranged over the lower ground, ground, and two upper floors. The two properties are fully integrated, with the lower ground floor of the main house extended beneath the mews, allowing access to the mews from this level.

Both properties share access to the private terrace situated between them at the raised ground floor level. A lift is also included, providing access between the lower ground and fourth floors. The property has modern technology and air conditioning installed throughout.

















Location

Queen's Gate is a highly sought-after residential street located at the heart of South Kensington. Its prime location allows residents to enjoy the vibrant atmosphere and amenities in the area, including an excellent selection of shops, bars, and restaurants.

The property is conveniently situated near the South Kensington Underground Station, which is serviced by the Circle, District, and Piccadilly lines, enabling excellent transport connections to explore the city with ease. Additionally, St Pancras International, directly accessed via the Piccadilly line, facilitates the convenience of international travel, providing seamless connections to various destinations. 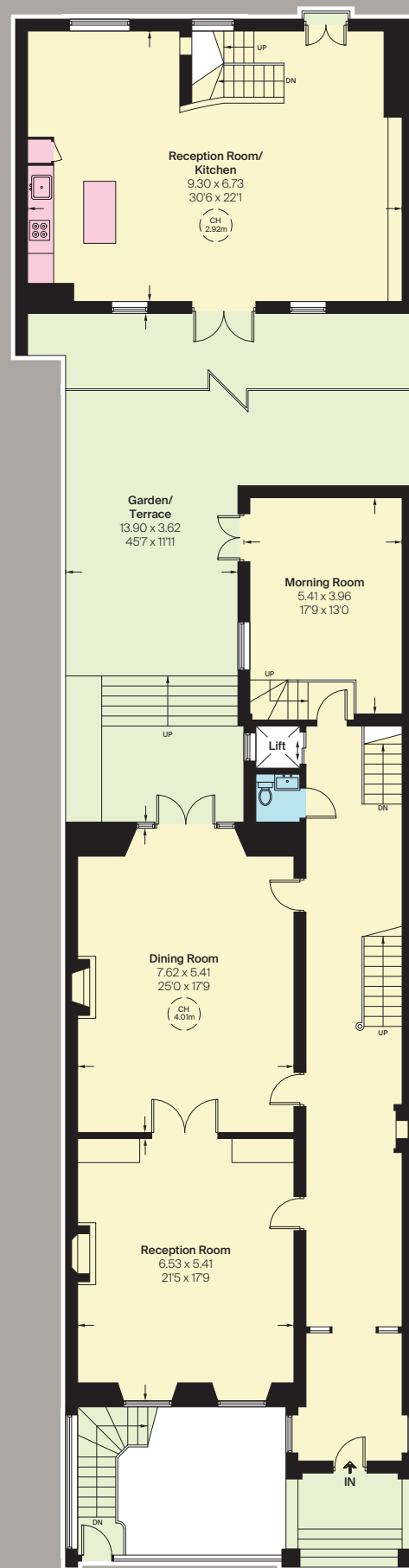
Mews Entrance Ground Floor



Mews Lower Ground Floor

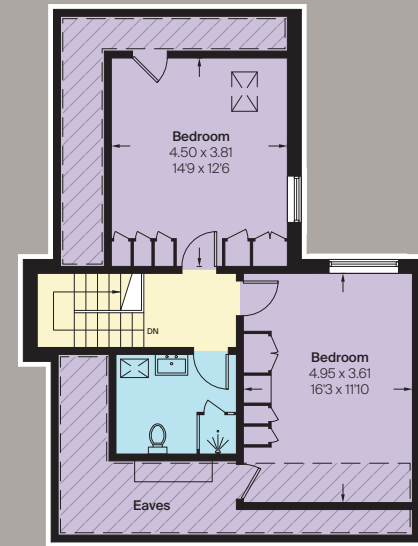
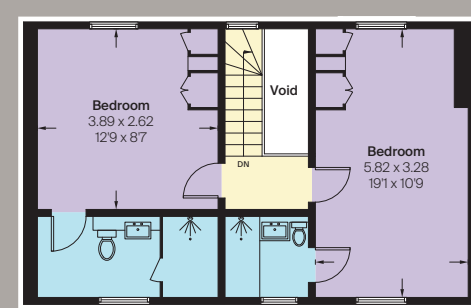

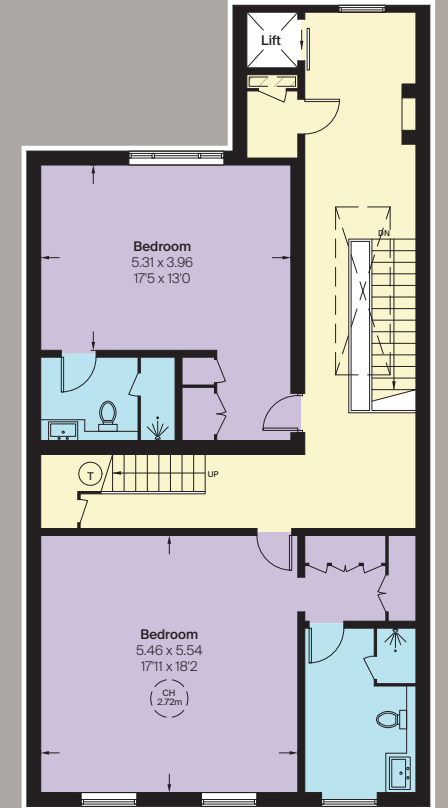
Mews First Floor



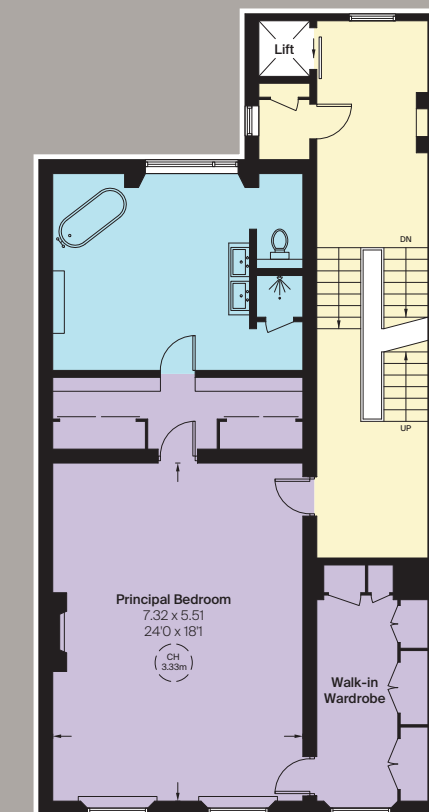
Sixth Floor



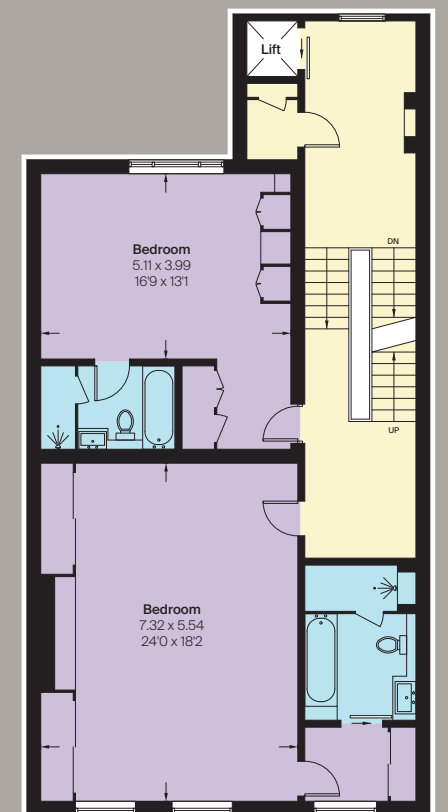

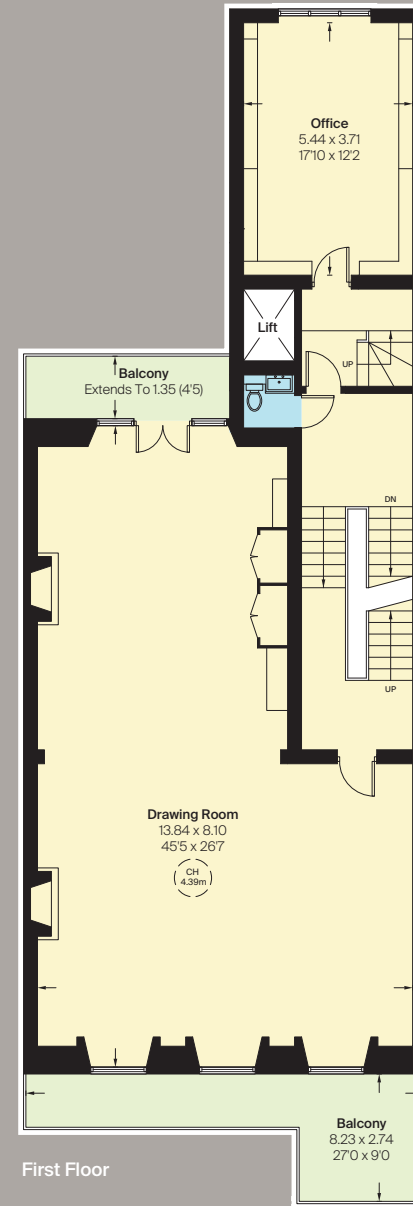

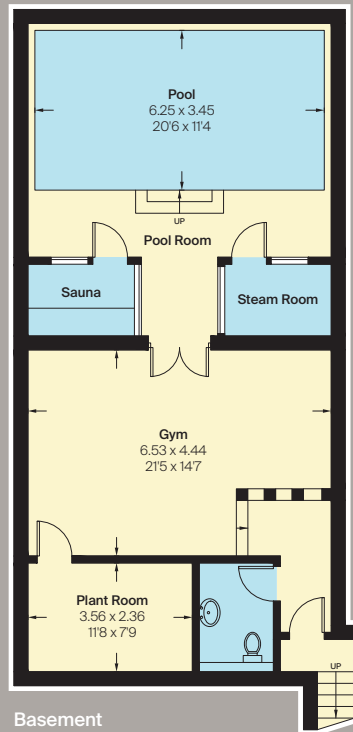
