



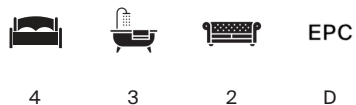

The lower ground floor includes a media/playroom, kitchen, and dining room with direct access to a patio. The basement level provides a further reception/bedroom with en suite bathroom and access to an additional patio. On the ground floor, a wide reception room leads through to a study, with access onto the garden. Upstairs, the first floor is dedicated to a generous bedroom suite with en suite bathroom. Two further double bedrooms and a family bathroom are arranged across the second floor, while the third floor offers a single bedroom or study. With a 35ft garden, patios and versatile living space spread across six floors, this property combines classic proportions with practical family living, ideally positioned in the heart of Chelsea.
