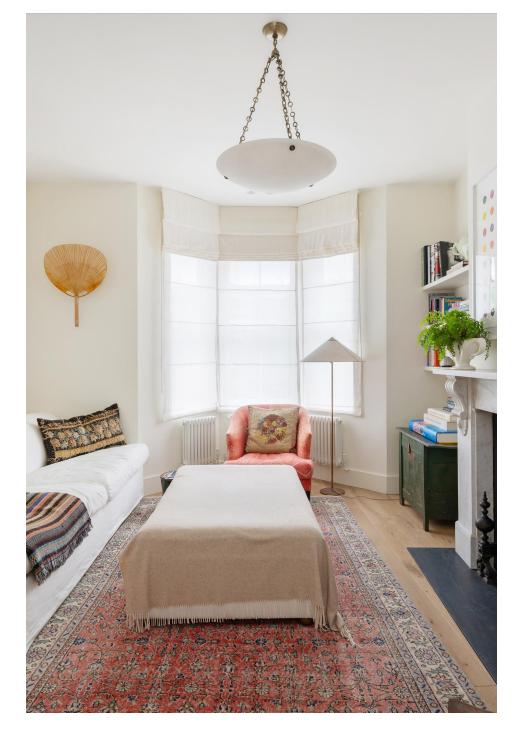

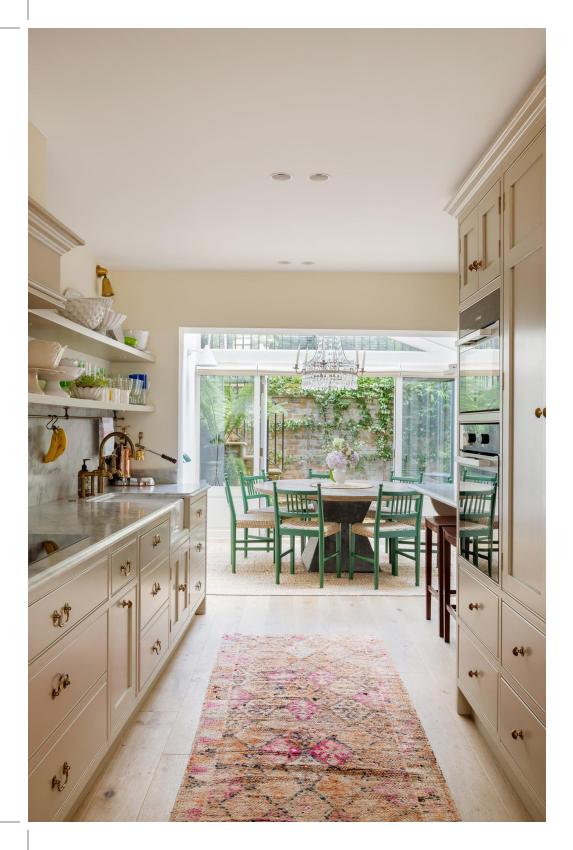
#### **BRIGHT INTERIORS**

Located in this highly desirable position opposite Hampstead Ponds and the Heath, the house is set across five floors and comprises of 2,577 sq ft.

On the raised ground floor there is a bright and airy double reception room with high ceilings. On the lower ground floor there is a reception room that leads to a 'Plain English' kitchen with conservatory, a guest WC and laundry room. On the first floor there is the principal suite which features a sizeable bedroom with excellent storage and a beautiful en suite bathroom. The upper floors house three further bedrooms, each of which has an en suite.







### GREEN OUTSIDE SPACE

The house further benefits from a beautifully landscaped 55ft private rear garden as well as a front garden and side access. The South Hill Park Conservation Area is a popular family neighbourhood which has the advantage of having no through traffic and abuts Hampstead Heath.
