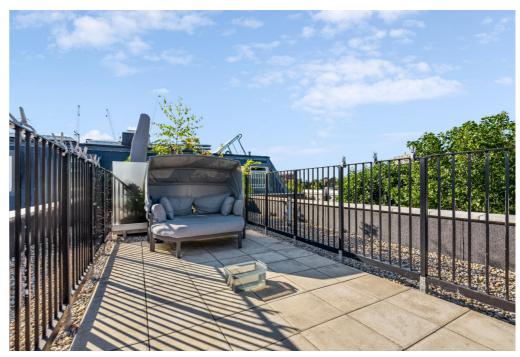




Location

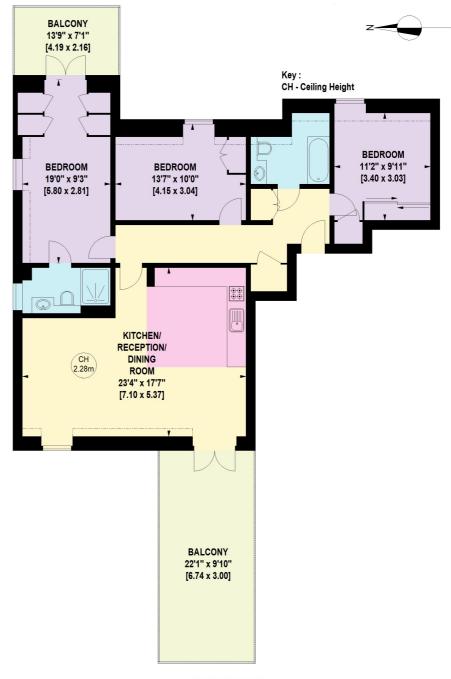
