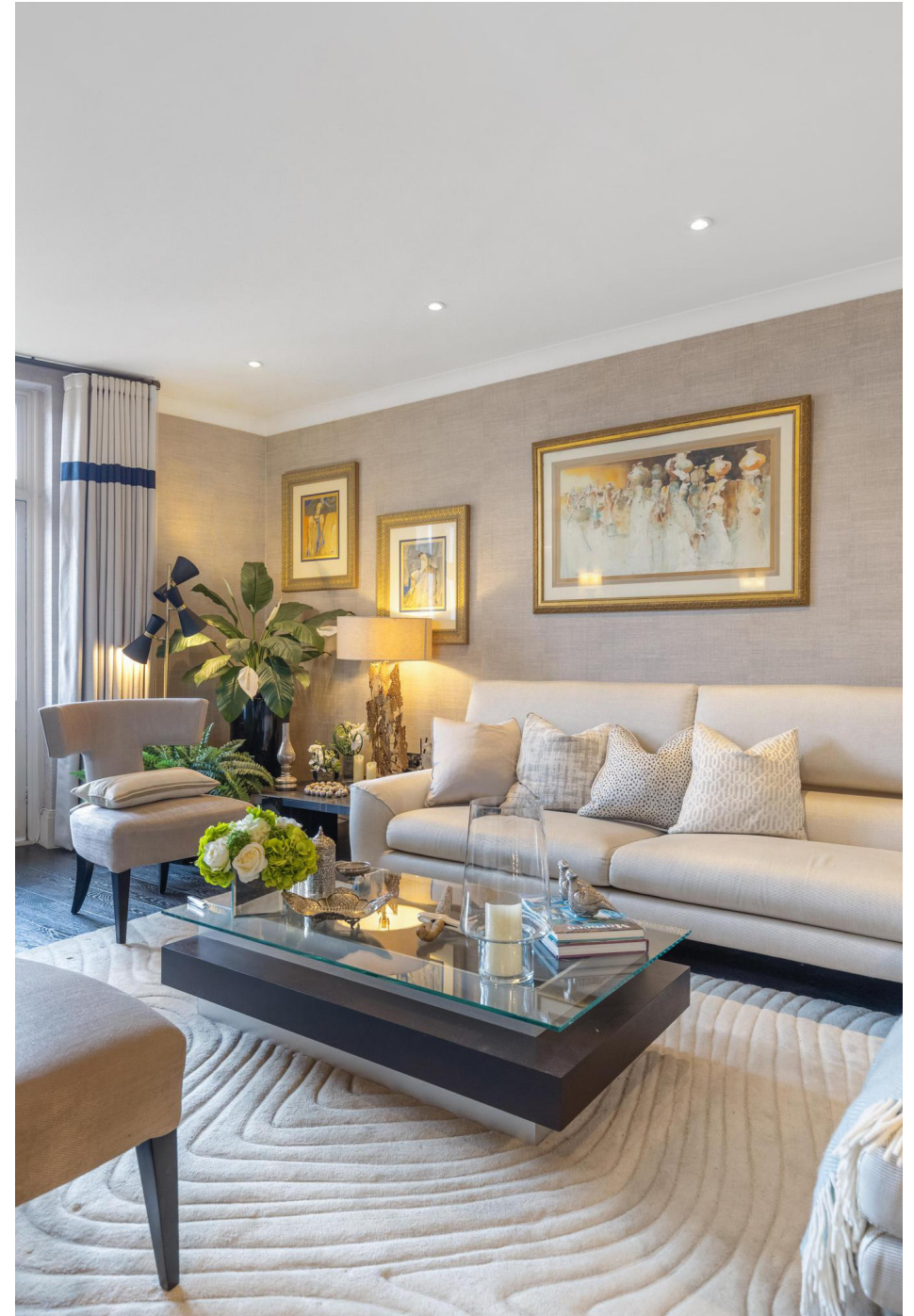

The residents further benefits from access to communal gardens.

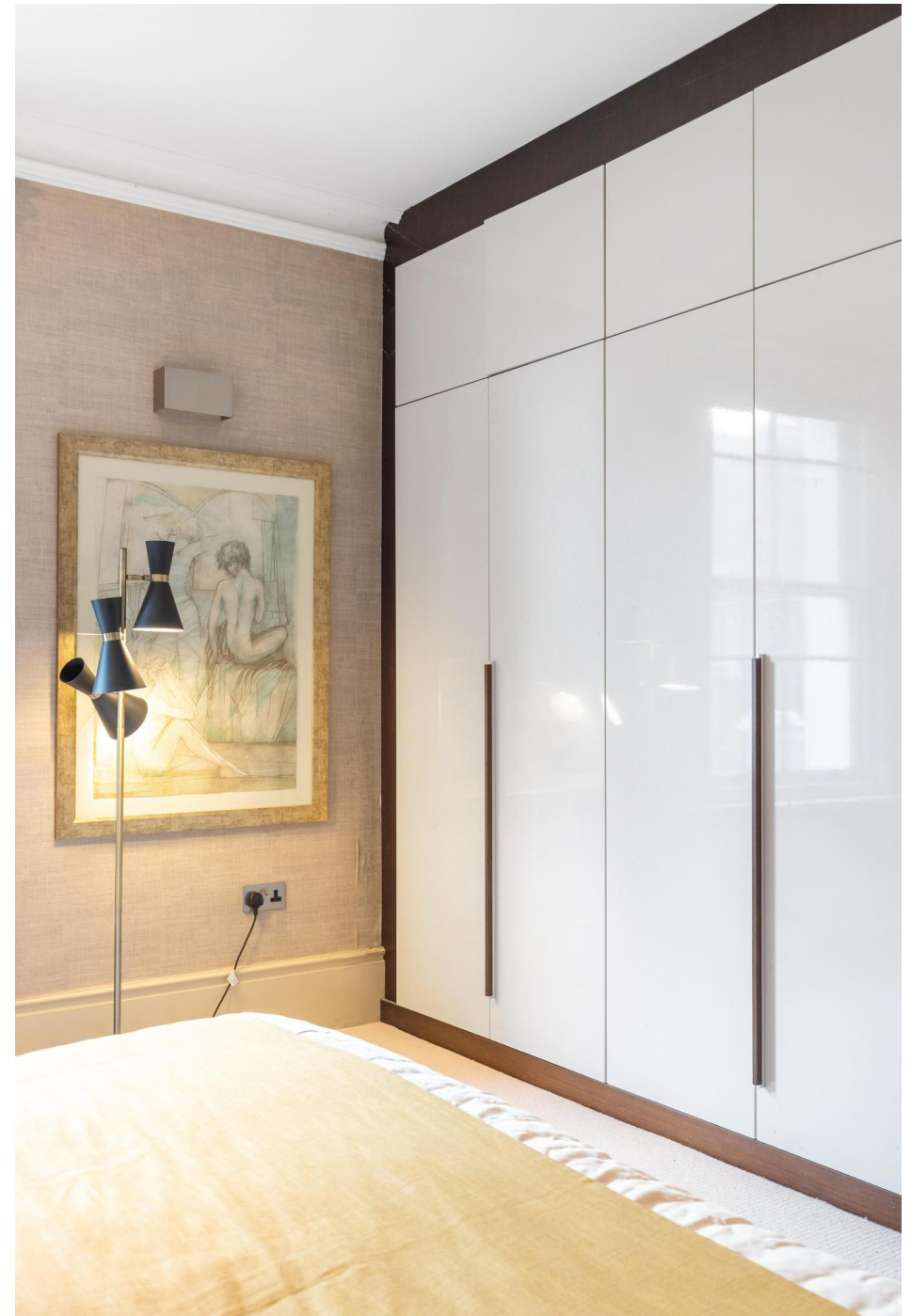


LOCATION DESCRIPTION
