The building was meticulously refurbished and remodelled by The Crown Estate in 2013-2015, to provide just a handful of beautifully appointed laterally arranged apartments with private parking.













There is 24 hour concierge service and given the presence of the Royal Palace at St James's opposite, the immediate area benefits from the highest level of security. This is in addition to the building's own security systems to include CCTV throughout.
