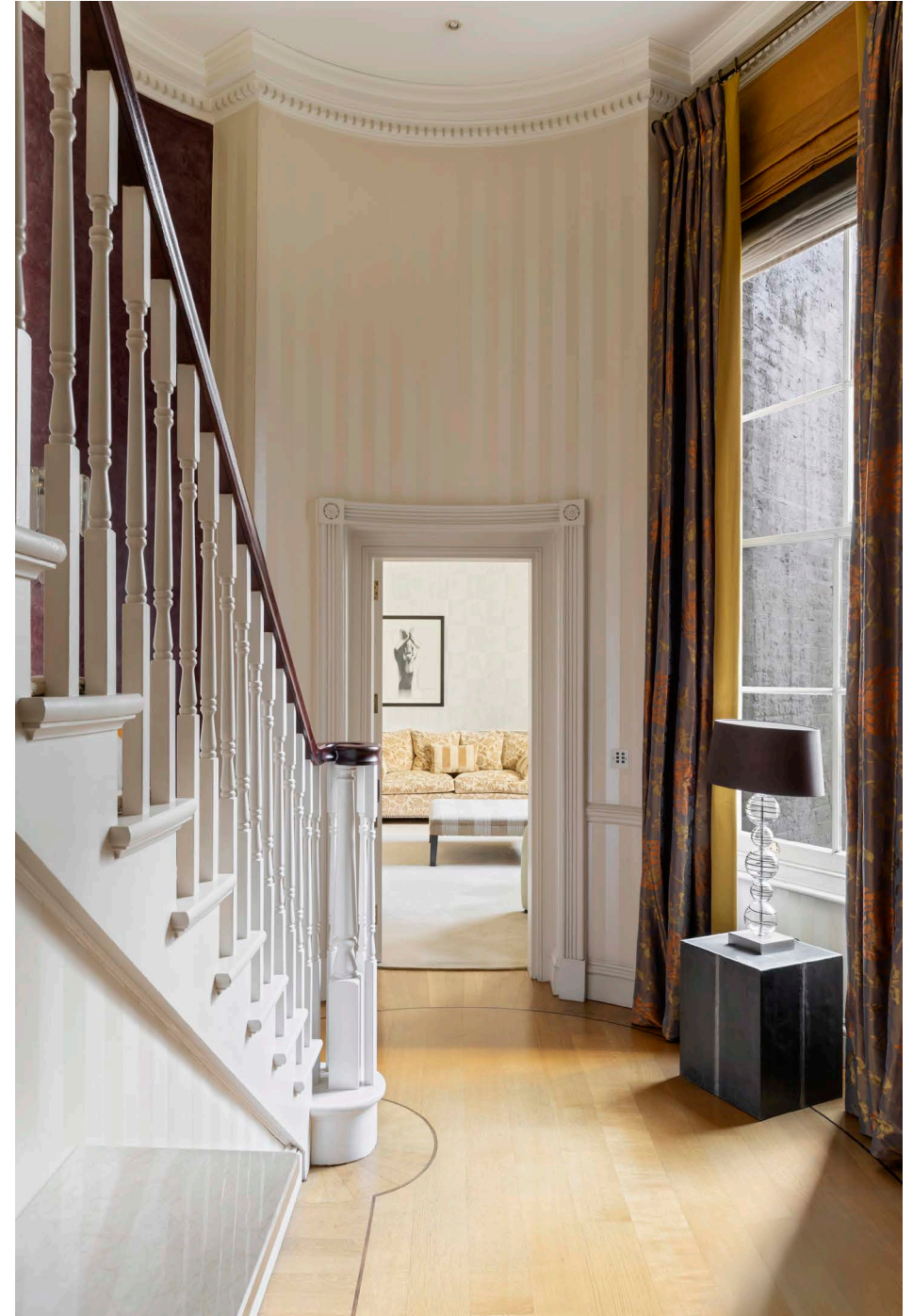

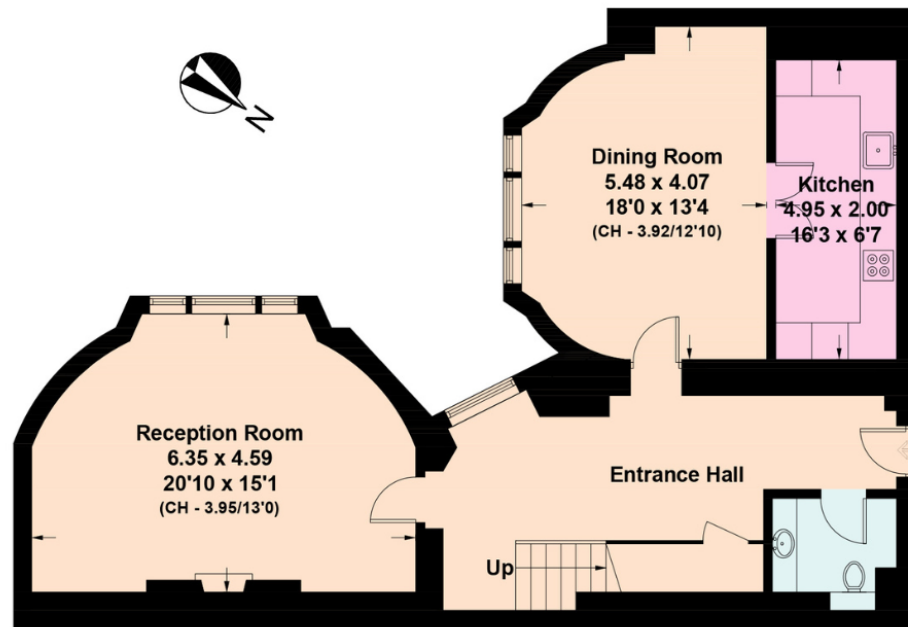

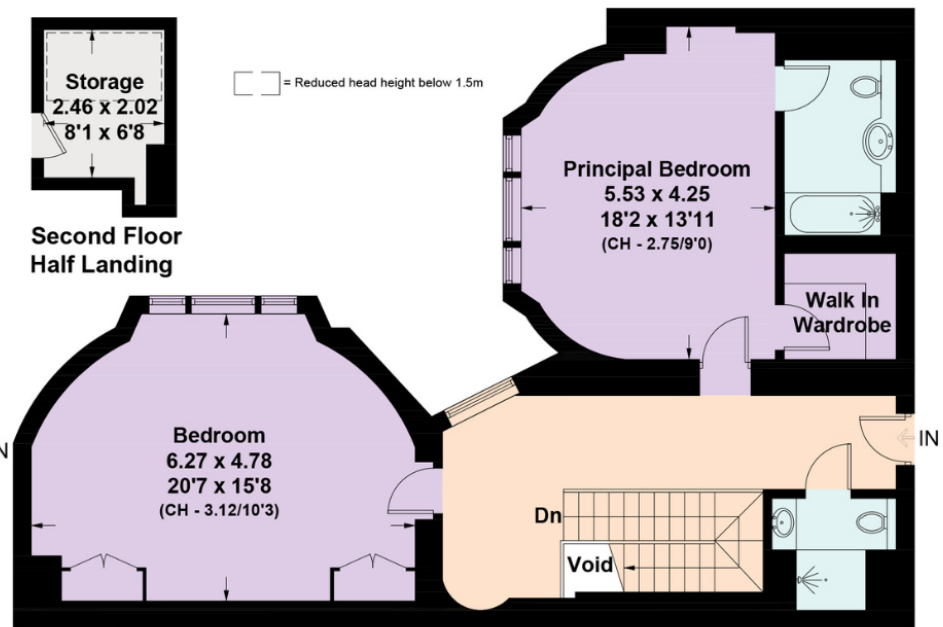








First Floor
