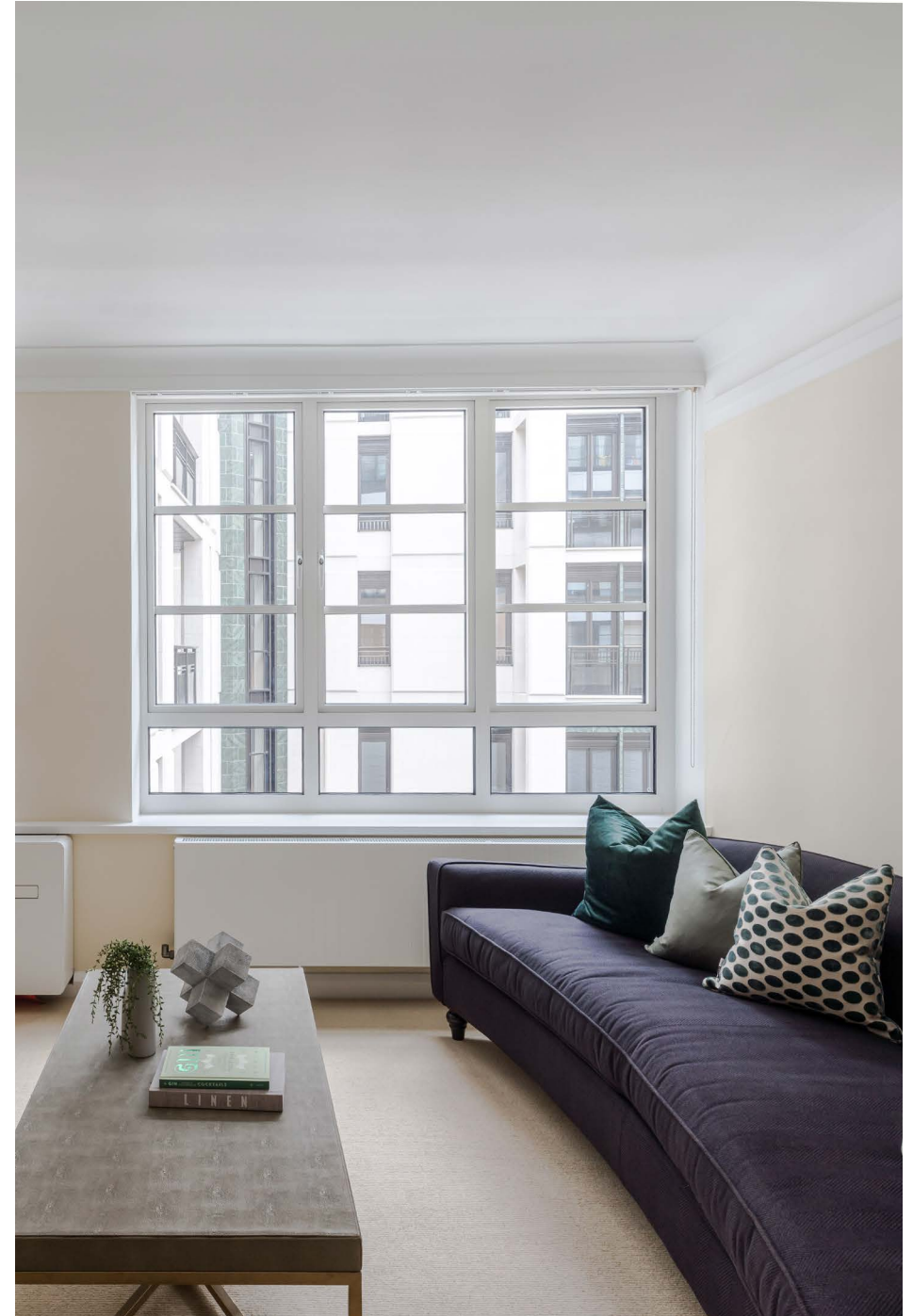

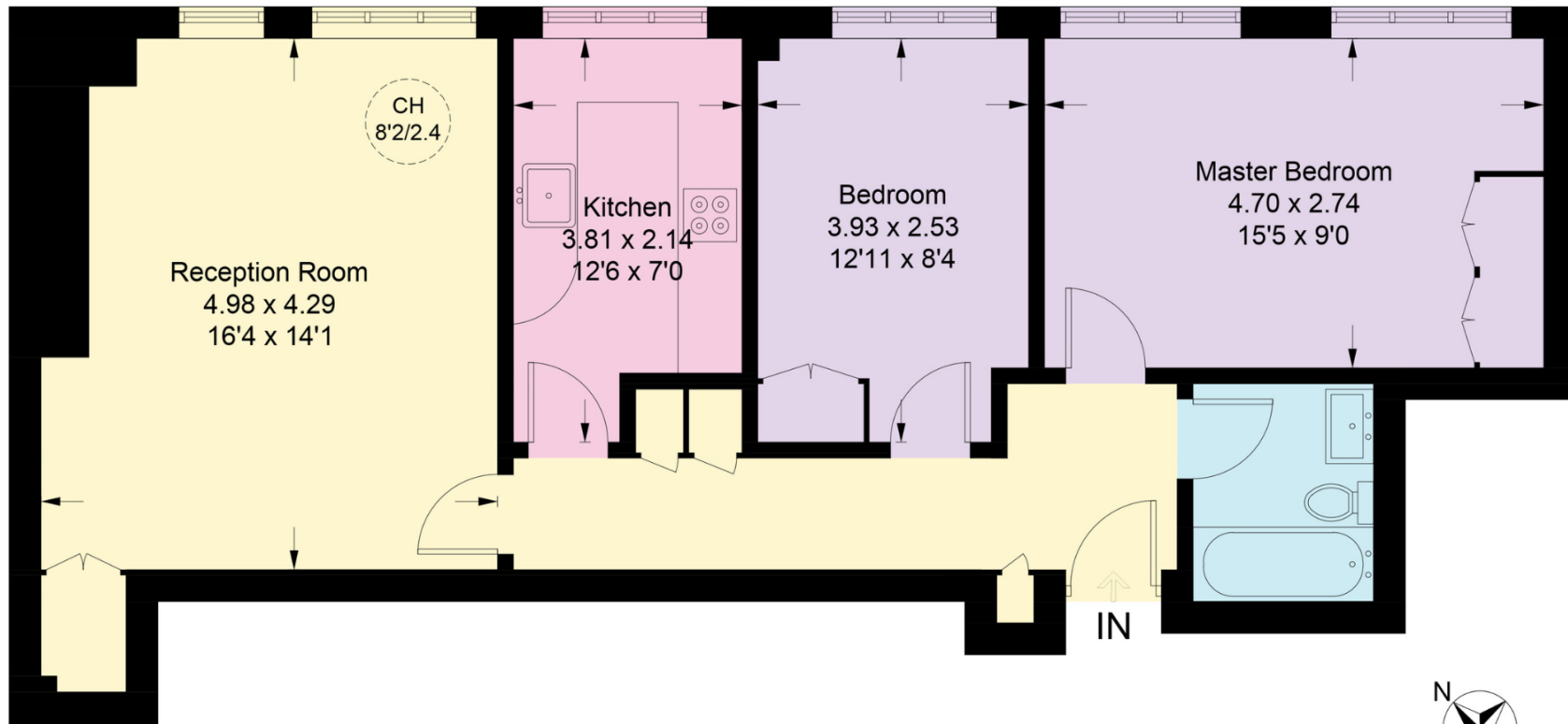
Located within a well maintained residential building moments from Green Park, this beautiful two bedroomed property boasts good living spaces, bright rooms and concierge. Arranged on the first floor (with lift) the property comprises a generously sized reception room with large, full width windows and contemporary fitted kitchen with integrated appliances. The principal bedroom is a very generous size and benefits from large windows and fitted wardrobes while the second bedroom (or study) also benefits from fitted wardrobes. There is fitted storage on the main hallway, and a tiled bathroom. Clarges Street itself is prime location for access to local amenities around Berkeley Square as well as Curzon Street.
