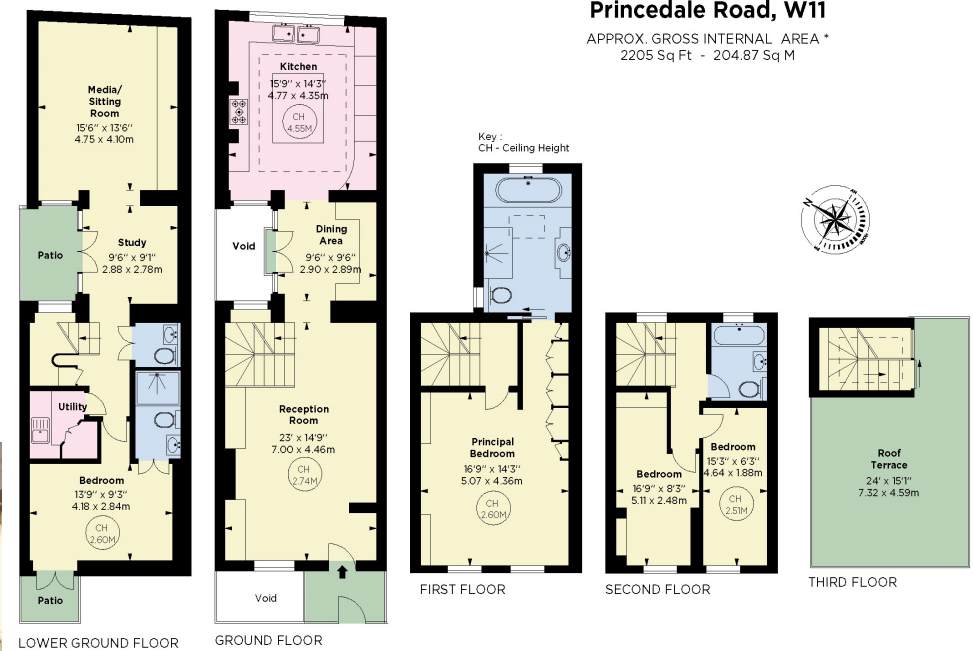

An elegant four bedroom freehold house on desirable Princedale Road in W11. Spanning approx. 2,205 sq ft over four floors, the property offers flexible living, generous ceiling heights, and two patios with access to a roof terrace. The ground floor includes a double reception room, dining area and kitchen beneath a large skylight. The lower ground floor provides a bedroom with patio access, study, media room, utility and shower room, ideal for guests or family use. Upstairs, the principal bedroom occupies the first floor with en suite and walk-through wardrobe. Two further bedrooms and a shower room are on the second floor, with the roof terrace above. Princedale Road is a tree-lined street near Holland Park Avenue, close to Clarendon Cross, Westbourne Grove and Holland Park station. The house has the right to apply for access to St Norland Square Gardens, subject to a waiting list.
