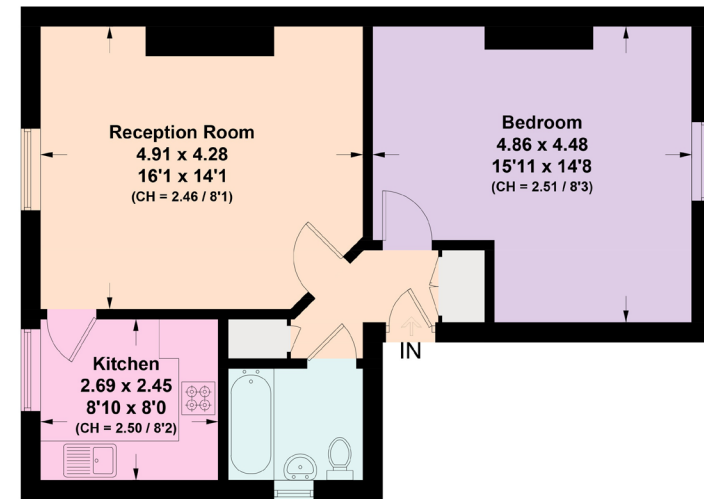
This charming one-bedroom flat benefits from exceptional natural light and generous proportions. Situated on the second floor of an elegant period building in the heart of Notting Hill.
