


## SPACIOUS APARTMENT WITH PERIOD CHARM

This beautifully presented two bedroom lateral flat occupies the first floor of an impressive white stucco townhouse close to Notting Hill Gate. The flat spans two terraced houses, creating a generous sense of space with notably high ceilings and refined interiors that reflect the building's period character. The entrance hall opens into an elegant reception room, where a stained glass bay window and full length sash windows flood the space with natural light.
