The large, spacious reception / dining room and open plan kitchen spans across the full width of the property on the ground floor. An open slat staircase leads to three bedrooms on the first floor. 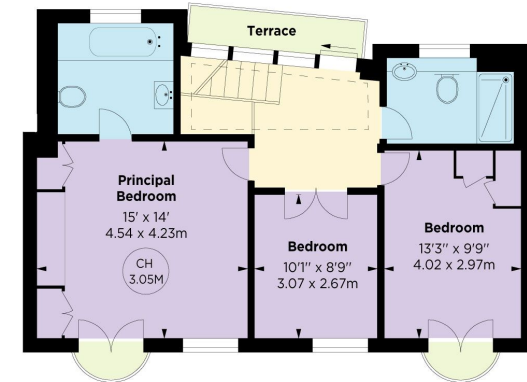


LOWER GROUND FLOOR
